1.1. Project Review Meeting



The Nagaland Forest Management Project (NFMP), an externally funded project: funded by Japan International Cooperation Agency (JICA) and implemented by the Department of Environment Forests and Climate Change (DEFCC) Nagaland had a Review Meeting at 11:00 am on 24th July 2019 at the Office of the Project Management Unit, Forest Office Complex: Kohima to review the progress of the project activities in presence of the Hon'ble Minister Shri. C.M.Chang and Shri.L.Kire IFS, Addl.Chief Secretary to Hon'ble Chief Minister, DEFCC, and DUDA. The NFMP Project is for a period of 10 years and on 31st March 2019, the project has completed its 2-year preparatory phase. From 1st April 2019 the Implementation phase has started.

Shri. L. Kire, IFS in his remarks appreciated the department for the achievement made so far in the project. He also shared his experience and gave valuable inputs on how the project can better perform. The Hon'ble Minister in his short speech highly appreciated about the progress made at the level of Divisional Management Units.

The meeting was attended by the members of the Project Management Unit (PMU), Forest Department Secretariat and all the 11 Divisional Management Unit (DMU) Heads. The Chief Project Director Shri. Dharmendra Prakash IFS, PCCF gave a brief overview of the project. The three Project Directors (PD) namely Shri Vedpal Singh IFS, APCCF- PD (Implementation, Monitoring and Evaluation), Shri Supongnukshi IFS, CCF- PD(Human resource development, Research and Public Relations) and Shri Meyipokyim Aier IFS, PD (Administration, Finance and Procurement) gave a PowerPoint presentation with regard to the progress made in their respective areas. The PCCF & HoFF and Chairman of NFMPS Shri. Rajat Pal IFS in his remarks spoke words of encouragement to all the officers of the Department.

The DMU heads gave a progress report of the works done at the field level. All districts had obtained the Prior Informed consent (PIC) from the villages that are selected for implementation of the project. Aside from this, DMUs had conducted awareness and sensitisation programme at the selected villages for proper implementation of the project work, started eco- friendly and plastic free nurseries by using alternatives such as bamboo and cloth bags at the JFMC nurseries for the Forestry Intervention Models. DMU heads also reported that most of the Offices and Quarters constructed under the project are almost complete.

The review meeting was chaired by the Chief Project Director while Dr.Kenei IFS CF(STC) welcomed the members before the start of the meeting and Smt. LhinghoikimTouthang IFS Deputy Project Director proposed the vote of thanks.

1.2. Convergence meeting and Consultation

Shri Supongnukshi IFS PD (HRD) gave a brief introduction of the project and also welcomed the Officials from Agri Department led by Dr.Amenla Jt. 2. TRAININGS, WORKSHOPS& EXPOSURE VISITS

2.1. Consultative meeting of PMU with the Nagaland Bamboo Mission as part of its preliminary study for Bamboo Scooping

As a part of the Bamboo Scooping Study as envisaged in the work plan for the project, a consultative meeting as well as a brief exposure visit to study the activities of the Nagaland Bamboo Development

Agency was undertaken at the Bamboo Resource Centre, Dimapur Nagaland. A four member team of the PMU, viz, Mr. Meyipokyim PD, Mr. Supongnukshi PD, Ms. Kim Thoutang Dy. PD& Mr. Ango Konyak Dy.PD visite ptp centre or the of Marsh 2019. This study aims to come up with a detailed analysis on the resource status and prospects on the value additions and market linkages on bamboos for the state.

2.2. Consultative workshop on Bamboo Resources

Resource Organization on Jhum and Biodiversity (ROJB) under PMU organized a workshop on Bamboo resources on the 22nd of October 2019. The workshop was held at the conference hall of the Forest office complex, Minister hill Kohima on 22nd October 2019.





The Chief Project Director, Shri. Dharmendra Prakash IFS in his inaugural speech talks about how bamboo is an integral part of life due to its versatile adaptability and uses, with about 1500 documented uses of bamboo in various fields. The Director also highlighted that after the 2017 amendment of Indian Forest Act, Bamboo is no longer listed as a tree, where only bamboos grown in forest areas would continue to be governed by the provisions of the Indian Forest Act. This is an opportunity for farmers to undertake bamboo plantation to increase their income and the step also would boost the bamboo enterprise section. Under the Nagaland Forest Management project there are provisions for livelihood improvement of the rural populace and bamboo enterprise development can be one component towards this end. He also talks about the "Act East Policy" and how the state should take advantage of this opportunity in terms of bamboo enterprise development for the economic development of the state.

The technical sessions of the workshop include the following power-point presentations and speeches on the following topics:

- ➤ "Bamboo diversity, its role in climate mitigation and sustainability: A case study of Mokokchung District, Nagaland." by Ms. Maongkala Walling, Research Scholar, Nagaland University.
- ➤ "Geographic Information System (GIS) and Remote sensing- technology and Application" by Shri. Meren from Nagaland GIS and remote Sensing Centre
- "Utilization of Bamboo in Rural Nagaland: A case study of Mokokchung District" by Ms. Temjensola Jamir, Research Scholar, RFRI Jorhat
- > "Bamboo Improvement Program at RFRI Jorhat" by Shri. Mohammad Ibrahim Scientist D, RFRI Jorhat.

Discussion hour was led by Conservator of Forests, Dr. Kenei Miachieo, IFS, where participants from the Divisional Management Units, Field management Units, Project Management unit and the Resource persons deliberated and discussed the way forward with regard to the roadmap for the Scoping study. The workshop was chaired by Shri. Supongnukshi IFS, Project Director and vote of thanks was proposed by Smti.LhinghoikimTouthang IFS Dy. Project Director.

A PowerPoint presentation on Nursery Register was presented by Shri. Anurag Verma (PMC Team). Shri Supongnukshi IFS, Project Director (HRD) gave a PowerPoint presentation on Jhum/Shifting Cultivation in Nagaland. The PMC and PMU Officials had an interactive session with the DMU and FMU heads in the later part of the program.

Shri MeyipokyimAier Project Director (AFP) delivered the introductory speech and gave a presentation on matters relating to Books and accounts of NFMP. The training on Accounting and Office Accounts Procedures was given by Neichuno Mor, Accounts Manager (PMU Support Staff) and Vizono Kintso, Accounts Assistant (PMU Support Staff).

Another session on GPS hands on was thereafter conducted for the attendees by the PMC experts.





2.6. Capacity Building Workshops

DMU Head Peren, Smti. Sentitula IFS deputed by PMU participated in the workshop at Agartala organized by Tripura JICA on 9th August 2019 on the topic "Production and Industrial use of Bamboo: Issues, Prospects and Challenges"

DMU Head Wokha Smti. Zuthunglo Patton IFS, and DMU Head Zunheboto Shri. Rajkumar M IFS attended a workshop on Challenges for Biodiversity conservation and Human-wildlife Conflict identifying the problems and possible solutions at Sikkim on 15-17 November 2019. The workshop was attended by Wildlife Institute Of India, NGOs and states having JICA funded projects. Shri. Rajkumar M IFS also gave a presentation on the topic "Wildlife Conservation and emerging conflicts In Nagaland" – Trends, Issues and Successful solutions.





2.7. Exposure visit to Japan

DMU Head: Mokokchung, Shri. Ao Chuba IFS attended the "Knowledge Co–Creation Program on sustainable Forest management and Integrated Watershed Management under counterpart training program" held at Japan from 19th August 2019 to September 6th 2019.

The 21 days module was packed with different activities with hands on experience on Management of Forest Park to Private Forests and Prefecture Forests to National Forests. Forests Management is being done for environmental protection, protection from natural disasters (typhoon, frost etc) and protection of agricultural lands by undertaking massive windbreak plantations. Good quality seedlings for plantations (high yielding species, pest and disease resistant plants) were produced through plant breeding techniques at High-Tech nursery managed by private corporations. Japan has successfully implemented a high-tech Soil & Moisture Conservation for control of erosion. The Foundations for Forest & Nature Conservation are actively involved in forest conservation & beautification.

In Japan, large scale production of Shitake Mushroom provide alternative livelihood to the rural poor, which can also be adopted in our state. The forest based waste management is another interesting practice, where leaves, twigs, branches and other wastes were used to produce electricity and wooden fuel pellets. Visit to Japan was exhilarating with a bundle of novel experiences. It's undoubtedly true as the saying goes 'Japan has something to take home for everyone who visits'.



3. INSTITUTIONAL STRENGHTENING

3.1. PMU Office Renovation

The Project Management Unit Office is being set up at the ground floor of the Forest Office Complex Kohima. During the month of April 2019, setting up of Office Cubicles toaccommodate the Support Staffs was completed. In order to accommodate the PMC, furnishings and renovations were also undertaken afterwards.

3.2. Mobility

The road condition of most of the interior parts of the Districts and Villages are unfriendly and non motorable due to the unruly terrain. The only way to access these areas is through two wheelers. Keeping these situations in mind and to meet the connectivity needs of the field officers, the Project Management Unit had purchased 22 two wheelers and 2 each per Divisional Management Units was distributed at the Office Complex of the PCCF & HOFF Kohima.






5. INNOVATIONS FROM THE FIELD

5.1. Peren: During its visit to the project villages the DMU head and field staffs found that even though the households were equipped with gas connections their consumption of fire wood as a fuel source has not gone down. This was attributed to cooking of pig food using fire wood and almost all the households were engaged in rearing pigs. thus for the purpose of sustainable livelihood and conservation of forest the forest officials conducted an awareness programme to switch to dry feed for the pigs as well as a training programme on animal healthcare

5.2. Zunheboto: Linking of traditional weaving centers with e-commerce initiative for Emlo and Yesheluto Village. Converging with Division website which is under construction (To be developed free of cost using small CSR) Convergence with Union ministry of textiles. Promoting home stays in Community Reserves. Promoting Ecotourism through digital marketing for Mishilimi especially during Tuluni festival in Pughoboto



5.3. Kiphire: The Divisional Management Unit Kiphire had visited the entire selected villages under its division and conducted a sensitization program. Two villages were taken up amongst the batch I village. The remaining to villages were picted bysthe officials as a part of pre-sensitization and plantation drive during the month of June 2019 was undertaken. They had distributed and planted one tree per household as a JICA Tree in all the project villages.





5.4. Kohima: DMU Kohima had the first plastic free nursery in the State. The DMU had invited the JFMCs of the project villages under the division to its Central nursery for handholding on plastic free nursery. 



KIPHIRE DIVISIONAL MANAGEMENT UNIT

1. INSTPUTTONAL STRENGTHENING

The strengthening of Institutions in terms of creation of physical infrastructures and Capacity Building of officers and staffs implementing the Project at the division level is one of the objectives of Nagaland Forest Management Project (NFMP). In order to improve the physical infrastructure in the newly created Kiphire Forest Division, creation of two offices and five staffs quarters has been proposed under this component. This has been taken on the priority basis in the beginning of the Project, all the construction works began in the year 2019 and almost completed by the end of November 2019 overcoming the remoteness of the district.

The Capacity Building of the executive staffs and other supporting staffs implementing the Project at the field level is another area which is being continuously given proper attention throughout the year. A number of training and workshop has been attended by the officers and staffs of this District at Kohima to get proper orientation for its execution at the village level. The mobility of the officers and staffs has also taken care of through the distribution of a dedicated vehicle for field officers and other staffs for project related works at the district level.

1.1. Engagement of Contractual staffs

Interview for the engagement of Planning & Livelihood Expert, Capacity Building, Information Exchange and Documentation Expert, Data Entry Operator, Account Assistant, Driver & one Office Assistant was conducted on 5th February 2019. These support staffs will be engaged in supporting the DMU officials in the field activities as well as for official works. A One Day Orientation Programme for the support staffs was conducted by the PMU official and Project Management Consultant at Kohima on 19th November 2019. A special training was also given to the Account Assistant in January 2020 regarding the Project Accounting Procedures to be followed by all the offices at the District & Range level as well as by Joint Forest Management Committee (JFMC) in the NFMP villages.

2. CREATION OF PHYSICAL INFRASTRUCTURE

This is one of the three major components under the Nagaland Forest Management Project (NFMP). Under this objective, seven construction works had been completed within a year including construction of Divisional Management Unit Office, Kiphire and Field Management Unit Office, Kiphire. In addition to these official quarters of Range Forest Officer, two Forester quarters and two Forest Guard quarters have been constructed. All the construction works related to all the seven buildings have been completed in November 2019. All these works has been completed by the District officers under the constant supervision of Executive Engineer engaged from Public Works Department by the Project Management Unit, Kohima. A 25 kilovolt transformer has also been installed within the premises of Forest Colony, Kiphire for supply of power to all the newly constructed building with the help of Power Department. The cost of transformer installation was also borne from NFMP. Total cost of the transformer installation was Rs. 4, 52,099/- (Four Lakhs Fifty Two Thousand Ninty Nine Only).

2.1. Distribution of 2 wheelers:

The project involves the frequent movement of executive staffs in the NFMP villages, Catering to this requirement, two 2-wheelers were also allotted to DMU Kiphire in June 2019 for mobility of staffs in the Project Villages. This is in addition to one Bolero for DMU Kiphire and one Gypsy for FMU Kiphire received by the Kiphire Unit of NFMP in last Financial Year.

2.2. Installation of Solar Lights in Forest Colony, Kiphire

Apart from the construction works under the Project, a total of Eight Solar Street lights were also provided by the Project Management Unit, Kohima for the installation inside the Forest Colony, Kiphire. All the Eight Solar lights were installed inside the Forest Colony in the month of November 2019 ensuring proper lighting in the Colony regardless of power supply in the district.

3. ANNUAL REVIEW MEETING

As per NFMP guidelines, Annual Review Meeting at the Division level and District Level are mandatory during the mopth of March of the following year with the purpose to provide a platform to all the stakeholders and shareholders for exchanging their view, learning's, ideas, pondering and identifying any social, technical & managerial issues, studying best practices, as well as for drafting overall frameworks for the annual implementation plan for the incoming fiscal year.

It mandates the presence of representative from all NFMP villages, NGO (if engaged), all DMU official & staffs and all the FMU Heads and concerned staffs under the chairmanship of DMU Head of the concerned division for the Divisional Level Annual Review Meeting.

The District Level Meeting is to be conducted through District Advisory Committee (DAC) Meeting under the Chairmanship of Deputy Commissioner.

3.1. Divisional Level Annual Review Meeting (20th March 2020)

The Annual Review Meeting was conducted on 20th March 2020 at DMU Office Kiphire. The two representatives from Batch I villages were called to share their opinion, feedback and suggestion about the project activities at the villages. All the DMU staffs were also requested to share their experiences gained in the last six months since their joining. The Treasurer from the concerned Villages were also oriented on ways of maintaining a proper systematic record pertaining to accounting while following up with funds being utilised for the project activities. Shri James Tikhir, SDO(C), a delegate from the Office of the Deputy Commissioner, Kiphire attended the Annual Review Meeting chaired by Shri. Rajesh Kumar IFS, DFO cum DMU Head Kiphire.

During the meeting, following officials and support staffs made positive contributions for the success of the project - Shri. Siechutho Katiry, ACF cum ADMU Head ,Kiphire; Shri. Bendangtemsu, FRO cum FMU Head, Kiphire; Shri Napoleon K, Planning & Livelihood Expert; Shri Atsali, Documentation Expert; Shri Nuheymong Yimchunger, Account Assistant. There were some suggestions being made from different officers/staffs during the meeting. Some important suggestions as consolidated at Division level include followings:

- Need to have a training for the specialized staffs engaged at Divisional level to improve their effectiveness vis-à-vis Project Implementation.
- Proper Sensitization of NFMP village for balancing the Short Term Gain and long term Goal as enshrined in the Project Document.
- The selection criteria of SHG should be based on the prevailing realities of the District.



- Provision of Office Expenses at the Division Level to meet the expense for smooth running of all the Offices under DMU Kiphire, as well as to reimburse the expenditure incurred in transportation of some equipments from DMIL Office ree Version
- One Projector for creating awareness among the NFMP villages through some relevant documentaries during the field visits.
- One Desktop and Printer for FMU Office for its smooth functioning.
- Some flexibility in terms of plantation target to be achieved in Batch I village under FMU Kiphire

3.2. Annual Review Meeting at the District Level

The Annual Review Meeting under the District level under the Chairmanship of Deputy Commissioner was scheduled to be held on 25th March 2020 through the District Advisory Committee (DAC) at the office of Deputy Commissioner .However, it was postponed due to Lockdown announced as a preventive measure of Covid-19 spread. This will be conducted after the removal of Lockdown at the suitable time.

4. PROJECT INTERVENTIONS AT NFMP VILLAGES

This is the focal point among all the objectives enlisted in the Nagaland Forest Management Project (NFMP). Under this component, the appropriate Forestry intervention as per approved Micro Plan made by Joint Forest Management Committee (JFMC) after due deliberations with all the stakeholders will be taken up for implementation. This intervention will be executed under the constant supervision of Executive Body in the NFMP villages elected by the General Body, Joint Forest Management Committee (JFMC) of the concerned village.

As per the directive received form PMU Kohima, two villages from DMU Kiphire were selected as Batch I Villages out of a total of eighteen villages from the District. The selected villages under Batch I from Kiphire include Anatongre and Yangzitong 'A' & 'B'. In these villages, all the preparatory works like Prior Informed Consent (PIC), Village Sensitization about the Project Objectives, Household survey, Demarcation of Geographical Boundary through GPS coordinates, JFMC Formation were done in the previous year.

4.1. Project Activities in Batch I villages in the Current Year

The preparation of Micro Plan was the first major activity undertaken in these villages. In absence of any Non-Governmental Organization and other DMU staffs for the project purposes, this exercise was undertaken by JFMC Executive Body with the help of Department Officials. Unfortunately, due to some differences amongst the villagers in Yangzitong, works were put on hold from June 2019. Despite our sincere efforts to sort out the difference among the villagers amicably, no significant breakthrough was achieved. All the field works related to preparation of Micro Plan, Selection of EPA activities and Water Harvesting Structure were completed till that time.

Anatongre was the stand alone village under which the field work was started in the current year. It started with the approval of Micro Plan in June 2019 by Conservator of Forests (Northern Territorial Circle) vide letter No. NTC/NFMP/PRC/711 dt. 10th june 2019 o/o CF(NTC), Mokokchung. Following the approval of Micro plan , the nursery works started in june 2019 itself to raise the seedlings needed for the plantation works to be undertaken in the following year under chosen Forestry Model for this village.

All the Five models were chosen under Forestry intervention in Anatongre Village. A total of 329.2 Ha areas have been identified based on the survey conducted by the field staffs with the assistance of Villagers. The Description in terms of Models and area selected has been included here for the kind reference.

In the current year, the nursery having a total requirement of 91,042 seedlings of selected species has been created catering to all the models. As per the availability of seeds in the villages and species chosen, the plantation activities for the Forestry Intervention Models (Model 4 & 5) have been deferred for one year. The remaining seedlings also didn't show the reasonable growth conducive for plantation activities till February 2020. However, as the cropping season in the village begin in April every year, it was believed that the plantation for the remaining three Forestry model will take place as planned. Towards the final weeks of the current year, a Nation Wide Lockdown was announced due to spread of Pandemic Covid-19. This Lockdown had closed most of the Government Offices as well as restricted the movement of all the people from one place to other places. The effect of this Lockdown on the Project Implementation in terms of adherence to the timelines will be estimated based on the total Lockdown period and the Weather Condition thereafter.

In order to monitor changes in the landscape of the area chosen under different model, Photo Points have been chosen. The number of such Photo Points depends upon the area of the concerned FIM and its topography. For monitoring the changes over the period of time in Anatongre Village, following Photo Points has been chosen, whose GPS co-ordinates are given below:



4.2. Entry Point Activities and Water Harvesting Structures in Batch I Villages

Anatongre was the only village in which the field works started in the current year. The approved activities under Entry Point Activities (EPA) and Water Harvesting Activities (WHS) were completed in this village. The "Fencing around the one Community Fishery Pond" was approved for activity under EPA for Anatongre Village. All the works related to this fencing has already been completed by March 2020.

Under Water Harvesting Structure in the village, a Water Tank of Dimension (12ft x 10ft x 8ft) was built near a Community Hall constructed by District Rural Development Authority (DRDA), Kiphire recently. All the works related to this construction has also been completed by the end of this Financial Year.

The significant aspect of both these activities in this Villages lies in the fact that the fencing around the Community Pond under EPA in this village where this same Community Pond was developed by Fisheries Department, Kiphire. The WHS has the provision to collect the water from the rooftop of Community Hall, constructed by DRDA, Kiphire. Both these Activities show a good example of Convergence among the different department working in the District. As Convergence has been given due importance in this Project, it will act as a good example to encourage in future, any possible Convergence of activities in the district.

4.3. Selection of Self Help Groups (SHGs) for Livelihood Support

A total of seventeen SHGs have been screened in Anatongre Village with the help of our staffs. They have been shortlisted as per their records and past activities and as per the criteria set out by the Project Management Unit, Kohima. A total of 4 SHGs have been selected for implementation of the project supported livelihood in the village.

4.4. Distribution of Solar Street Lights to Batch I Villages

A total of 16 solar street lights were received from PMU Kohima, for the distribution towards Batch I villages under NFMP. Originally, there are two villages selected under Batch I villages thus each Village

was given eight solar street lights for the installation in their respective villages in the location decided by JFMC Executive Body. All the solar street lights have been installed in Anatongre Village. However, the Yangzitong JFMC chairman in their villages owning to some differences with the Village Council about its location. In the Review Meeting held on 20th March 2020, JFMC Chairman, Yangzitong assured that it will be installed in next few days.

4.5. Preparatory works in Batch II villages under DMU Kiphire

A total of six villages were selected under Batch II segment from DMU Kiphire this year for the preparatory works for the Project Implementation. These villages include Koer, Bilongkyu, Old Resithse, Seyochung, Pokhpur & Penkim. All the preparatory works pertaining to Project Implementation has been completed during the year. The Prior Informed Consent (PIC) was taken from the concerned Village Council in the month of September. After PIC from the Village Council, the General Body meeting was conducted in the month of December in their respective villages, in which they were sensitized about the Project Objectives and about its implementation. The JFMC was also formed after due deliberations in the General Body Meeting. All the Executive Committee were also elected in the same meeting by the JFMC members. The extent of Geographical Boundary for the project purposes was also taken through collection of fifty GPS coordinates covering all possible reachable are by the FMU staffs for each Batch II villages with the villager's help. The House to House survey were also completed in the same month by the FMU staffs.

During the field data collection in the selected villages, an important issue raised by the concerned village council in regard to the survey & delineation of village boundary for the project purpose has been noted for further appraisal to higher authority. During the course of discussion and interaction in this matter with concerned village council/stakeholders it has come to the knowledge of the Field officers that some of these small villages like Keor, Bilongkyu being migrated from the same parent village, share some common areas for the purpose of jhum farming along the village border but outside their respective village jurisdiction. As such certain patches of Jhum lands along the village border but outside their respective district administrative village boundary setup is also being used by another village in the course of their respective village traditional jhum cycle. Therefore, it is suggested that delineation and preparation of village boundary map for the project purpose may be done as per the decision of the concern village council for effective implementation of the project.

2.1.1.2. Field Visits

An inspection of the nurseries set up at Tuophema village under Kohima was carried out on 20th August 2019. NFMP Consultant Shri A.K. Bhansal, CPD Shri Dhramenrda Prakash, ACF Shri Suvil Ltu, Smt. Rongsenlemla, IFS, DFO cum DMU head, DMU Support staff, FMU head and his staff visited the nurseries. Mr. Sasievi Kaco, JFMC vice chairman expressed his gratitude to the officials for their visit and informed that the saplings in the nurseries will be planted in those areas where there are less trees. JFMC Chairman, Mr. Dzieselhou Thong gave a brief demonstration on traditional method of raising khokon seeds. To make the seed bed, firstly bamboos are used as the base/ foundation, after which mixture of manures along with dried banana leaves and jute bags are spread throughout the seed bed. Khokon seeds are spread all over the bed and placed in an inclined position so that they receive ample sunlight which makes germination successful. This method of raising Khokon seeds is successful than the conventional method of raising

them in the nurseries as the seeds in the nurseries do not receive enough sunlight and thus germination is not successful.

For the development of the village, NFMP has contributed a sum of Rs. 3,00,000/- each for constructing marketing shed (EPA) and for constructing water harvesting structure within the village.

2.1.1.5. Organic Pesticide

On 12th November, Project Management Consultants members led by Shri. V.M Arora and his team, DFO Kohima cum DMU head Smt. Rongsenlemla Imchen IFS, DMU support staff, FMU Head and his staff visited Tuophema village. The visiting team monitored JFMC nurseries in the village and interacted with JFMC members. While interacting with the village members, Shri. V.M. Arora gave a brief description to the village members on how to make organic pesticide. It is made by adding 12 litres of cow urine, 16 litres of water, 1 kg of neem leaves (having insecticidal properties), 1 kg of jaggery and I kg of flour. All the items are stirred in a pitcher and kept in a shade for 15 days after which the liquid is extracted and used twice a month. Shri. V.M. Arora also suggested that adding a layer of sand inside bamboo culms can be useful while taking out the saplings so that the bamboo culms do not break. In this way, the bamboo culms can be reused.



An innovation taken up by the village embers is the treatment of dried saplings by keeping them above polythene sheet filled with water. This method of retention of stored water enables the saplings from drying up. During a brief interaction with village members at the council hall, Shri. V.M. Arora gave a brief introduction on the project and the importance of EPA and involvement of women's participation for the success of the project.

On 17th August 2019, the DFO cum DMU Head, NFMP Kohima, Smti. Rongsenlemla Imchen, IFS, forest range officer Tseminyu and DMU Support staff visited the nurseries. She encouraged the village people to be a role model for other village as well and hoped that they will continue to work with co-operation. She also encouraged Nsunyu village to make it a 'Plastic Free Village' and show an example to other villages. Also on 14th September 2019, Smti. Rongsenlemla Imchen, IFS, DFO Kohima, DMU Head along with DMU support staff visited Nsunyu Village under Tseminyu sub-division to inspect the progress of the nurseries. The nurseries were constructed in the month of July 2019. The visiting team also inspected the

JICA staff quarter located at forest colony. The construction of the Ranger's quarter commenced in the month of January 2019 whereas the Forest Guard quarter started in the month of September 2019.

2.2.1. Self Help Groups (SHGs)

In Zhadima village, there are 20 Self Help Groups (SHGs). Each group carries out different activities like weaving, gapdsping making local dish washers and so on. They sell the products within the village and also sell in the shops. Members of each SHGs collect a sum of ₹ 30 every month for fund generation and other activities. SHGs sell ginger, sugarcane, local garlic and other vegetables in marketing sheds on the highways to generate fund. Besides selling vegetables, they also work as daily wage workers. SHGs of Zhadima village were also planning to take up poultry farming in the days to come.

On 19th September 2019, the support staff of DMU Kohima went to Nsunyu village and interacted with the SHGs. In the village, there are eight self help groups (SHGs). The SHGs generate funds by doing business and farming. Besides farming, they also do sticky rice cultivation and sell second hand clothes for business. With the profit they earn, they give loan money with interest at 3% to individuals and groups and pay their children's school fees. If they are unable to sell off the things, they distribute it within the group. Every month, members of each group collect a sum of Rs. 50 to Rs. 100/- for their activities. They also go to the fields and earn by doing daily wage work. SHGs sell their agricultural produce in the marketing shed on the highways and also sell their goods in Kohima.



1.5. ANNUAL REVIEWS & MEETINGS

1.5.1. District Level Advisory Committee

District Advisory Committee of the Nagaland Forest Management Project Society was convened on 29th August at ADC Conference Hall. The NFMPS Team gave a Power Point Presentation about NFMP and some suggestions that were made by the committee members are as:-

- a) Proper care should be taken in species and site selection for forestry activities to avoid uneconomical occupation of productive lands.
- b) Proper co ordination with the line departments for the implementation of Nagaland Forest Management Project to do away with any duplication of efforts/villages with other projects.
- c) The role and responsibilities of the District Advisory Committee should be elaborated.

1.5.2. Divisional Level Annual Review meeting

The DMU level meeting was conducted on the 12th & 13th March 2020 at the Office Complex of the Conservator of Forest (NTC) Mokokchung. The meeting was attended by all the FMU heads, JFMC Presidents of the 3 Batch-I villages and the DMU Support staffs. After a thorough review of all the activities undertaken at both the support staff level and the field level functionaries and amongst many of the activities undertaken, the DMU Head highlighted the following points:

- i. Conflict Resolution: The FMU head Mokokchung has shared her experience in conflict management in formation of JFMC. The involvement of all stakeholders in the village is a must for formation of any activity/groups and the involvement of all the individuals in such issues.
- ii. Benefit of Households in the NFMP works: The involvement of Women/widows in the JFMC activity such as raising of Nursery etc and their benefits and livelihood improvement through the activity.
- iii. The Raising of Khokon seedlings: The Mongsenyimti JFMC has shared the traditional method of raising Khokon seedlings in the Bamboo groove. The Khokon seeds requires lot of water and the seedlings raised in the bamboo groove provides necessary nutrients and water for constant nourishment. The naked Khokon seeds gives better result.
- iv. Raising of Spondias seeds: The Mopungchuket JFMC has shared their experience of sharing the spondias seeds. The naked root survival is higher than that of Polybags in case of this species.
- v. Ban of Hunting: The Changtongya new JFMC villagers had a meeting with the village council and the council has issued total ban on hunting in their jurisdiction with immediate effect. The JFMC to coordinate with the forest department in all the forest and wildlife activities. He also shared the experience that the spondias seeds takes almost 5 to 6 months to germinate in their Nursery
- vi. Innovations in Ginger preservation: Ms.Akumnaro, the Livelihood expert has given an elaborate innovations for ginger processing and the involvement of SHG for the same
- vii. Types of Accounts to be maintained by DMU,FMU and JFMC: The detail structure of maintaining different accounts has been highlighted by the Account Assistant, Shri. Temsuwapang.











- viii. Importance of File Index and File Maintenance: The Proper indexing and filing of different files in a division for proper flow of information and correspondence was presented by the Shri.Nintanger Data entry/Coppp Assistantessor Free Version
- ix. Importance of Seed Collection: The importance of knowing the age of the tree while collecting seedlings for raising Nursery and the selection of proper site for establishment of Nursery was highlighted by Shri. Talimeren.Dy Ranger (Retd),the M& E and Convergence expert.





1.2. Annual review meeting According to the agenda forwarded by the PMU, Kohima, an annual review meeting was conducted on 20th March 2020 headed by Shri. Raj Priy Singh, DFO, Mon District.

3. BRIEF WRITE-UP - 'PROJECT REVIEW AND ACHIEVEMENTS'

JICA project in Nagaland has been under implementation in the state since 2017, Nagaland Forest Management Project (NFMP) activities under Mon Division carried out between 2019- 2020 is still under gradual development, Batch I villages under the project have mostly completed their community development activities like EPA and WHS. T. Chingkho and Mon Village activities are completed, whereas in Wanching village the activities are yet to be completed due to the lockdown and the JFMCs lack of access to materials for completion, since the village under Naginimora Range is bordered near state of Assam and the because inter-state movement is still prohibited. Due to the various infrastructural support given by JICA the project under NFMP Mon divisional unit has a total of seven structures that can accommodate various staff and Forest officials.

The implementation of the project in areas where Jhum is highly practised and the focus and efforts to work towards sustainable Forest Management and improve the quality of forest and in conserving forest through collective and participatory forest management. The JFMCs are helping village communities to develop and enhance their role in the management of project activities.



Advance work in the entire project villages have begun under different treatment models, there is also a need to issue proper and well formed guidelines for DMU, FMU and JFMC level in order for them to decimate proper information in relation to the project and also to assist and guide the communities for better participation and performance towards the project. Level of interaction and joint work between the JFMC and FMU seems to be positive whereas the overall community involvement and understanding of the project still needs to be worked on. Most village communities are still unaware of the project objectives and its possible outcome and advantage for the village and community as whole.

Highlights of the Annual Review meeting:

- (a) The activity of Advance work of the 1st batch villages which was hindered by lockdown can be resumed immediately by May 2nd week. The staff and the JFMC chairman will start the advance work immediately before the planting season ends.
- (b) The requirement for maintenance of register of JFMC meeting conducted, stock register, and transportation cost register of nursery, MB of nursery, EPA and WHS, Muster rolls for labour in nursery plantation/nursery register.
- (c) The forestry intervention models were explained in detail and simple manner to the JFMC and executive staff.
- (d) Maintenance of photo points of various activities accompanied by video for monthly activity report, annual administrative report, publicity and documentation.
- (e) The quality of seedlings raised in the nursery of the village is below standard so the reason for raising low standard seedlings in nursery may be due to faculty site selection, improper seed bed, inferior quality seeds, water logging, insect/pest attack etc. The height of the nursery constructed is low which may interfere with the free circulation of air and the size of the bed must not be of more than 1.5 metre width.
- (f) The status of construction of EPA and WHS of 1st batch was discussed.
- (i) Chimonger- Yet to start due to lockdown
- (ii) Langnok- Yet to start due to lockdown
- (iii) Yimrup- EPA (Completed) and WHS (80%) completed)
- (iv) Noksen EPA (completed) and WHS (80% completed)
- (g) To maintain the cash Account of JFMC in a proper way where the assistance of FMU Head and account officer of DMU Tuensang will be provided.
- (h) Available Nursery seedlings raised by the villagers species wise for advance work in first batch Village for starting the work by 2nd week of May 2020.
- (i) Final GPS mapping of treatment areas is done and sent for approval by the PMU.
- (j) Building completion certificate with picture is submitted to the PMU.

Suggestions/Remarks/Discussion

- 1. Training is required for the project for JFMC and executive staffs under DMU Tuensang.
- 2. The nurspyrmadenbyrgreen house is of low height which may be the possible reason for low grade seedlings due to improper circulation of air.
- 3. The nursery bed should not more than 1.5 meter wide as it becomes difficult for weeding and dibbling the seeds in the poly bag.
- 4. The nursery bed should be raised 15-20 cm to avoid water logging which may be the reason for the high mortality of seedlings in the nursery.
- 5. Uniform format for maintaining register temporarily under 1st batch village for monitoring purpose

On Day 1the meeting was held in the Office Chamber of the DFO cum DMU Head, Wokha, and was attended by the EAC Wokha, FMU Head Wokha Range and staff, Doyang staff, JFMC President and Head GB of Wokha Village, JFMC President of New Riphyim and DMU Support staff. On Day 2 the meeting was held in the Office compound of the FMU Head, Wokha Range, and was attended by the FMU Head Wokha Range and staff, Doyang staff, JFMC President Wokha Village and DMU Support staff.

During the discussion hour, some deliberations on rise in nursery costs due to use of bamboo containers and nursery cloth bags were made and it was decided to use some low cost eco-friendly containers which would bring down the cost as well as fulfil our need for such containers in our NFMP Nurseries. The JFMC members and staff didn't favour nursery cloth bags because of unfavourable results, almost all saplings died and the cloth bags rotted away within 2-3 months. According to their observations, the bamboo containers gave better results compared to cloth bags but were found to be too costly amounting to atleast Rs.2.5 per container. Mr. Khonbemo Lotha, Forester- II, Wokha Range, suggested the idea of using bamboo sheaths to make eco-friendly nursery containers to grow saplings which was received with great enthusiasm by all present and it was decided to immediately try making some for demonstration purpose and video documentation was done (soft copy enclosed). Three different types of bamboo sheath nursery containers were made:

• *Simple bottomless type* – One rectangular strip of bamboo sheath is cut in the desired size and soaked in water to soften it. It is then folded into a cylindrical shape and the ends are stapled together with a stapler. Three of these containers can be made from big bamboo sheaths of Dendrocalamus giganteus, locally known as "Enung".

- With bottom (Type 1) One rectangular smaller strip of bamboo sheath is cut out and soaked in water and then folded over the simple bottomless container at one end and stapled to the sides. Three of these coptings can be mader from his hamboo sheaths of Dendrocalamus giganteus, locally known as "Enung".
- With bottom (Type 2) One square strip of bamboo sheath is cut into desired size and soaked in water. 2 parallel cuts each on 2 opposite sides of the square sheath are made and then folded to make a container and stapled together. Two of these containers can be made from big bamboo sheaths of Dendrocalamus giganteus, locally known as "Enung".

The bamboo sheaths of Dendrocalamusgiganteus (Enung), D. Hamiltonii (Vepvu/Kako), Bambusa pallida (Tsintsan), etc can be used for the purpose of making these bamboo sheath nursery containers for raising nursery saplings. Since bamboos are abundantly available in all the NFMP-JICA selected villages of Wokha District as well as other districts of Nagaland, these eco-friendly bamboo containers can be easily replicated in all the JFMC nurseries at a very low cost. Material can be collected for free or at a minimal rate and transportation costs are also greatly reduced as compared to when transporting bamboos.

Since the time for acquiring Parkiaroxburghii (Yongchak/Tree bean) seeds for sowing in the germination beds or directly into the containers is near (March end/April), the DMU head urged the FMU heads and JFMC presidents to try these bamboo sheath containers on pilot basis for yongchak seedlings which was agreed upon by them. Although it is easy to make such containers from bamboo sheaths manually and for the JFMC nurseries, the JFMC members themselves would make them, it was also decided to suggest to the PMU for ordering a custom-made machine for bulk supply if deemed fit.

The use of Areca catechu (tamul) sheaths was also suggested but was found to be unsuitable due to its bulky nature.

The advantages of use of bamboo sheath containers for nursery are as under:

- 1. More economical / less costly
- 2. Easy availability of the resource
- 3. Easy to transport the material from source to the JFMC nurseries
- 4. Easy to make all three types of containers
- 5. Easy to plant as one need not remove the bio-degradable sheaths and can plant directly
- 6. Most importantly, these are eco-friendly
