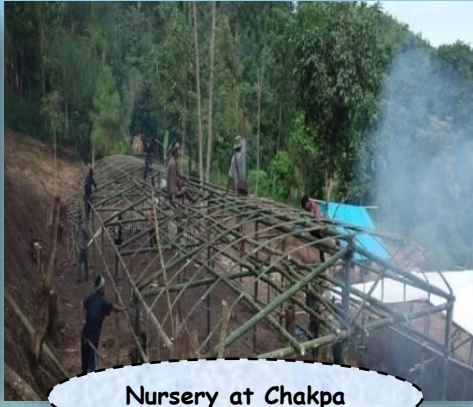

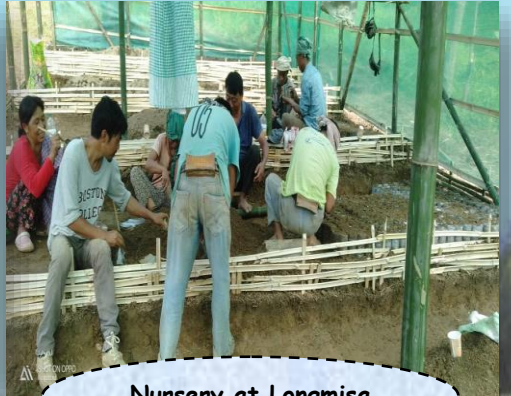

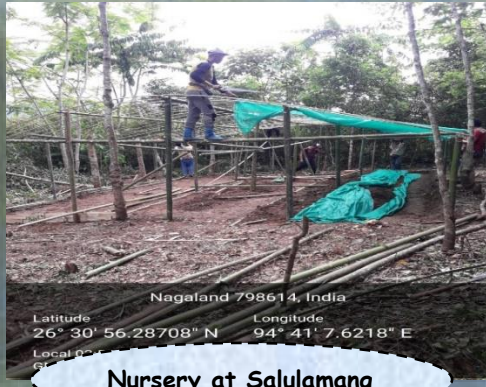

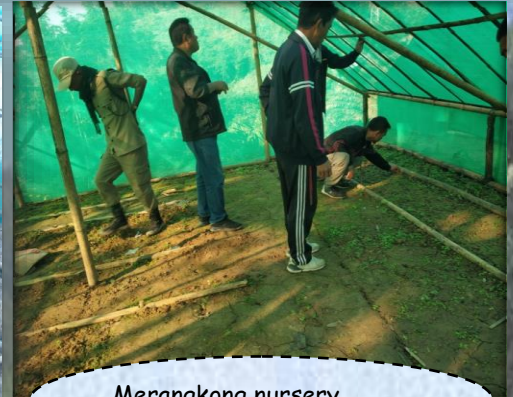

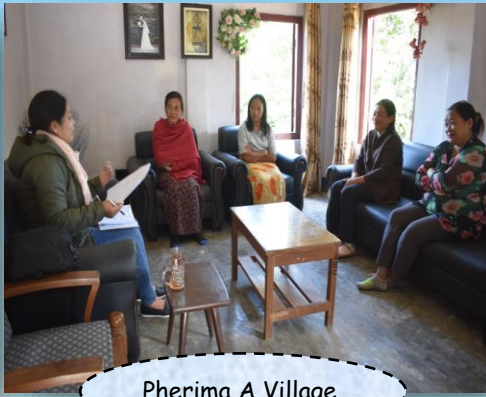

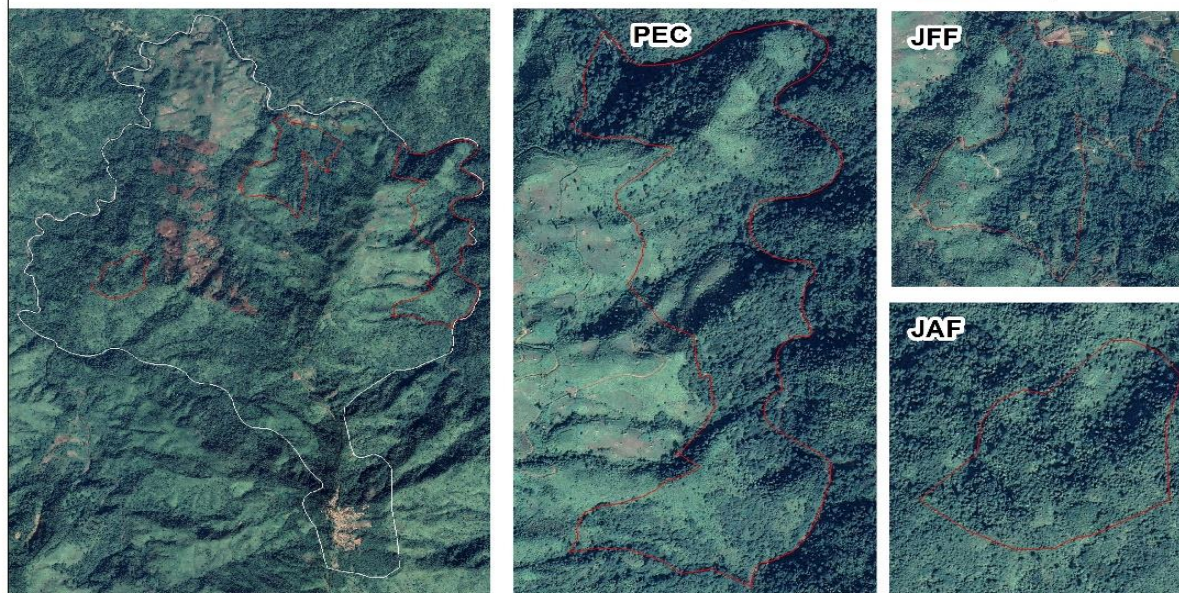

SATELLITE MAP OF YIMRUP VILLAGE

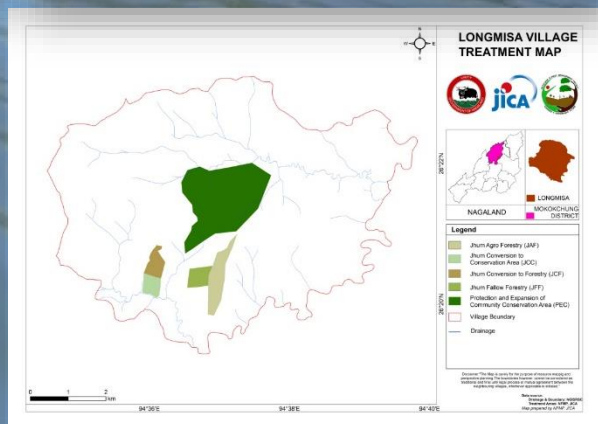
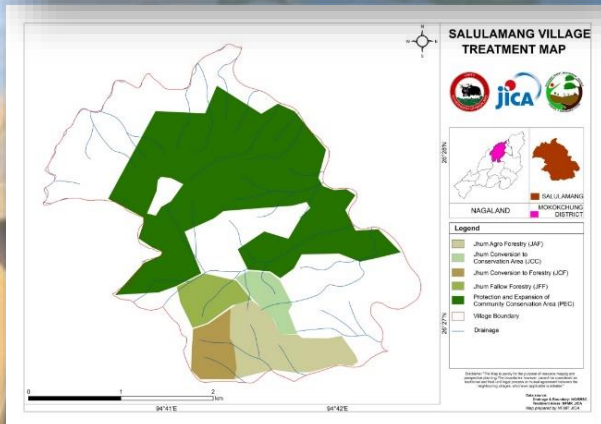
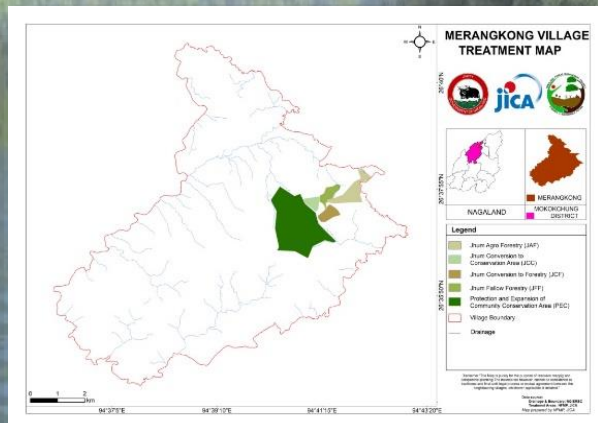
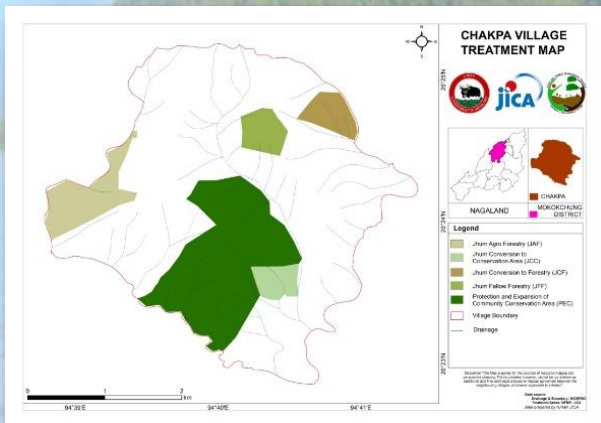
YIMRUP VILLAGE SATELLITE MAP
