# HIGH POWER COMMITTEE (HPC) MEETING

The meeting of the High- Power Committee of Nagaland Forest Management Project Society (NFMPS) was held at 1:30 pm on 30<sup>th</sup> March 2021 in the Chief Secretary's Conference Room, Nagaland Civil Secretariat, Kohima. The meeting was attended by the members of the High-Power Committee and Special invitees.

Following is a brief account of the deliberations and decisions taken during the meeting:

- Shri. Dharmendra Prakash IFS, CPD cum CEO briefly presented the background, project objectives and implementation of the NFMP.
- Shri. Vedpal Singh IFS, Project Director (I, M & E) presented the Forestry Intervention Models in Batch-I villages, its key achievements, progress of the Batch-II Microplan. He also highlighted about various maps in the villages and monitoring activities which involves the site inspection visited by members of the Project Management Unit Officials in the district level. An overview about the development of M & E framework was also presented in which he explained that the implementation phase would require the coordination of the NGOs in collecting the data at the district level supported by the PMU.
- Shri. Limasanen Longkumer, GIS Expert presented various modules of Web GIS applications and Mobile applications developed for collecting the field data for the project.



 Shri. Supongnukshi IFS, Project Director (HRD, R & E) highlighted the key aspects of Project implementation involving the awareness generation and capacity building which includes stakeholders such as PMU, DMU, FMU and JFMCs. He also presented the Monthly Reports, Quarterly Reports, Newsletters and Annual Reports of FY 2019-20.

- Shri. Jayesh Bhatia, International Expert & MD, NRMC, New Delhi gave a brief introduction about its involvement in the NFMP as Project Management Consultant (PMC). He presented about PMC's participation in preparation of Project Manuals, guidelines, conducting Training Need Assessment for JFMCs and SHGs. He also presented the work plans of PMC for April to September 2021.
- Smti Anungla Phom Joint Director, DUDA presented an overview of the Department of Under Developed Areas (DUDA) where over 380 SHGs have been formed with over 11400 household covered in eastern region of Nagaland. She also highlighted about the Van Dhan Yojana, a component of the "Mechanism for Marketing of Minor Forest Produce (MFP) through Minimum Support Price (MSP)" which aims at the socio-economic development of the tribal population of the country.
- Shri. Temjenyabang Jamir IFS Project Director (AF&P) presented the Financial Status of the NFMP as on 21<sup>st</sup> February 2021 and also placed the Annual Plan of Operation FY 2021- 22 and Audit Report FY 2019-20.
- Shri. J Alam IAS, Chief Secretary & Chairman. HPC observed that the successful implementation of the Project is crucial for the state as its success would



open the door for other projects in other departments. He also emphasized the need on the convergence of Agri and allied sector schemes and asked APC to coordinate between Agri and allied department for implementation of the project whenever required.

# WORKSHOP ON BAMBOO RESOURCES OF NAGALAND

A Workshop on Bamboo resources of Nagaland was conducted by Resource Organisation On Jhum and Biodiversity (ROJB) at the Conference Hall, Forest Office Complex, New Minister's Hill Kohima on 19<sup>th</sup> March 2021. The ROJB is an institution set up under the JICA assisted Nagaland Forest Management Project.



A brief introduction was given by Smti. Lhinghoikim Touthang, IFS State Silviculturists and CEO ROJB. Welcome address was delivered by Shri Supongnukshi IFS Project Director (HRD) NFMP. He gave an introduction on the importance of bamboo as a resource and the need of workshops and training in order to develop the bamboo resources of Nagaland and how Nagaland can play a crucial role in meeting the requirements for bamboo products in the country.



He also exerted on the huge potential Nagaland holds when it comes to bamboo industry

development however in order to start off, field information and survey of different bamboo products, its availability and necessity for market linkage needs to be studied so as to implement policies according to the survey. A powerpoint presentation on how to collect field data using GPS, which will act as the base line data for initial survey, and how to obtain the photographs, so as to help the experts identify the various bamboo species was presented by the GIS Team, NFMP. A brain storming session along with all the Field Officers present was held where discussions on how to go about was held and it concluded that a pilot village (Mongsenyimti village) be selected Mokokchung district for initial survey/study and implementation process so as to help standardize the format/template for data collection, after which the actual work will be initiated.
