Terms of Reference (ToR) for Team of Expert
at Nagaland Resource Organization on Jhum and Biodiversity (NROJB)

1. BACKGROUND.

In Nagaland, 60% of the total population relies on natural resources (agriculture and forest) for their living. Forests contribute about 75% of the total geographical area, and within this jhum-farming is the predominant land-use. The Nagaland Forest Management Project (NFMP), with the financial assistance from Japan International Cooperation Agency (JICA) is being implemented to strengthen the forestry sector of the state, with long term goals of environmental conservation and poverty alleviation. The project aims to improve the forest ecosystem by promoting sustainable jhum and forestland management and biodiversity conservation work in 185 villages. The project targets to cover about 79 thousand ha of forest, jhum land and community conservation areas through different forestry and biodiversity conservation models. The project is getting implemented in 10 year time i.e. between 2017-18 to 2026-27. Institutional and information strengthening are important objectives of the NFMP. Thus, creation of Nagaland Resource Organization on Jhum and Biodiversity (NROJB) to further inter-disciplinary research on jhum in the state in particular and in the NE region in general, to support policy and practice, has been identified as one important intervention area under NFMP.

NROJB will function now under the institutional umbrella of Nagaland Forest Management Society and subsequently may be developed as an autonomous Society under the aegis of Nagaland Forest Department. It aims to foster inter-disciplinary research, action and knowledge management around shifting cultivation (jhum), forestry and biodiversity so as to shape appropriate policies and programs for sustainable resource management and livelihoods promotion, in the north-eastern region, specifically in the State of Nagaland. Its goal is to draw interests of large sets of stakeholders, including from different geographies (i.e. local to national to regional) and different disciplines (i.e. ecology, economics, agronomy, climate change, etc.).

(1) Research

- a. Participatory Exploratory Research to investigate the ongoing biophysical and socioeconomic interactions (including institutional and governance related) around jhum and forest landscapes and implications on biodiversity, livelihoods, climate change
- b. Participatory Action Research around project interventions to monitor the process (participation, governance etc.) and changes in landscapes and livelihoods
- c. Any other research as would be deemed fit or would be required to meet project objectives, compliment project processes

(2) Information repository on Jhum and Biodiversity in Nagaland and maintaining project database

- (3) Conduct capacity building of the project stakeholders and other relevant agencies around the Centre's work and learnings to effectivity disseminate and use the research findings.
- (4) Carry out regular publication of "the research findings for internal circulation (viz: IEC materials) and external dissemination (viz. research paper, website, media dissemination) ROJB shall be provided with following facilities.

2. POSITION SUMMARY.

An expert team will be the core of NROJB. It will be headed by a Director and include experts each from the fields of Forestry/ Biodiversity, Community Mobilization/ Sociology/ anthropology, livelihoods, livestock and communication. NFMP is looking forward to recruit four position as of now.

Director cum Forestry/Biodiversity Expert: Director will coordinate and manage various administrative and program operations of NROJB in close association with CEO of NROJB, PMU and PMC of NFMP. The successful candidate will be based at Dimapur and will travel frequently to various project locations including the NFMP office at Kohima. The position will be on contractual basis, with an initial contract for one year, subsequently extended with mutual agreement.

Four Experts: one in each of the field of Community Mobilization, Livelihoods, Livestock and Communication. Each should have at least a Master's degree with minimum of 10-15 year's experiences as a researcher or practitioner with Government/NGO/Private sector, with evidence of publication. The successful candidate will be based at Dimapur and will travel frequently to various project locations across the state of Nagaland. The position is on contractual basis.
