



#### About Nagaland Forest Management Project

The Project is an Externally Aided Project supported by Japan International Cooperation Agency (JICA) with the aim to improve forest ecosystem and support income generation by rehabilitation of Jhum area and provision of livelihood support, thereby contributing to sustainable forest and environmental conservation and livelihood improvement in the target villages in Nagaland State. The project has a target to cover 185 villages involving all Districts of the state spanning over 22 Forest Range & Beats. Duration of the project is 10 years.

This project has following three components:

- Forestry interventions and biodiversity conservation
- Livelihood improvement and community development &
- Institutional strengthening

#### The Project — — —

#### **—**Introduction

Nagaland is one of the North Eastern States of India situated on the eastern border with a population of about 1.9 million (2011) and is rich in forest resources within the Indo-Burma biodiversity hotspot.

Almost 60% of the State's population is engaged in Jhum (slash and burn) cultivation - a form of traditional cultivation that has evolved over generations and has become a core tradition of the Nagas. Jhum cultivation meets approximately 60% of food demand in the State. Under Jhum, cropping cycle of one or two years is followed by long fallow period to ensure fertility and nutrient cycling to maintain land productivity. The climate of the state is humid tropical and sub-tropical with steep terrain and Jhum cultivation results in depletion of micro-nutrients from the soil. It is also reported that Jhum cycle has been reduced particularly in the Eastern part of the State. The short rotation cycle of Jhum leads to lower productivity due to short fallow period. The state has the lowest yield per hectare from Jhum Cultivation among the North Eastern States. Average productivity in Nagaland is estimated at 702 kg/hectare while that in other North Eastern States it is approx. 1,193 kg/hectare. As a result, there is an increasing pressure on the forests for commercial exploitation to augment income of rural population. This pressure results in degradation of the forest resources and the biodiversity. According to the India State of Forest Report (FSI, 2021) Forest cover in the state was 12,251 sq.km. which is 75.33 % of its total geographical area, but more than half of it is in open forest category (having canopy density less than 0.40). Moreover, according to this report forest cover has been decreased by 450 sq.km, between 2015 and 2017, the fourth highest loss of the forest cover across the states in the country. Jhum cultivation is one of the reasons cited for the forest degradation. According to FSI report on Forest carbon in India's Forests (FSI, 2012) per ha. Carbon in the above ground biomass pool in the state has been estimated to be 12.08 tons which is very low compared to the national average of 31 tons per ha.

The biodiversity of the state is not only valuable for its intrinsic value, but also provides critical ecosystem services such as food sources, water sources, soil formation, nutrient cycling and primary production. Thus, sustainable restoration and rejuvenation of Jhum area is essential for restoration of forests and conservation of biodiversity in the state.

#### **—**The Project Objective

Nagaland Forest Management Project - NFMP (hereinafter referred to as the Project) was started during 2017-18 with the above background and assistance from Japan International CooperationAgency (JICA). The main objective of the Project is to improve the forest ecosystem and support income generation by rehabilitation of Jhum areas and provision of livelihood support, thereby contributing to sustainable forest and environmental conservation and livelihood improvement in the targeted villages in the State.



#### Project Costs & Components

With a total estimated cost of Rs.533 Crores, the Project is to be implemented in 185 villages in 22 selected Forest Ranges and in 11 Forest Divisions namely Mon, Mokokchung, Tuensang, Wokha, Dimapur, Zunheboto, Phek, Kohima, Peren, Kiphire & Longleng, covering all the districts of the State. The main approach is to undertake need based and village specific interventions in the Joint Forest Management (JFM) mode through the JFM committees (JFMCs).

Ranges/Independent Beats will be selected by applying the criteria of Jhum intensity, and forest cover. Villages within selected ranges/independent beats shall be selected batch-wise spanning over a period of 4 years, (30: 60: 60: 35 villages in batch 1, 2, 3 & 4 respectively) based on the criteria as given in Detailed Project Report read with the Minutes of Discussion (MoD) of 30th January, 2017 between the Dept of Environment Forest & Climate Change, GoN and JICA.

Selection of the target villages would follow in a cluster based approach i.e. a group of villages sharing the same geographical and vegetation landscape requiring similar forestry interventions, with a view to enhance project impacts in a tangible manner and to reduce administration cost and facilitate cohesive management.

While Making Selection Of Villages, Following Types Of Areas Is Being Avoided

- a) Areas where there are land disputes or community disputes
- b) Isolated villages which cannot be included in a cluster
- c) Villages which have been supported by other external (foreign) donors in the recent past
- d) Protected areas (eco awareness activities shall be implemented outside Protected Area)



### Schematic Representation Of The Project



#### International Conference on "BIO RESOURCES & BIO ECONOMY"

Nagaland Forest Management Project (NFMP) was invited to co-organize International Conference on Bioresources and Bioeconomy' with Department of the Botany, Nagaland University, from  $17^{th} - 19^{th}$ 

September 2022. Drawing from this dynamism of practices and perceptions around shifting cultivation practices. NFMP conducted two sessions around (1) A Tradition in Transition: Understanding the Role of Shifting Cultivation for Sustainable Development in Northeast India, and (2) Jhum and Biodiversity Nexus: Interdisciplinary Issue, Challenges and Opportunities. While one session focused on discussions around traditional practice of Jhum and NFMP's contributions towards forestry interventions, the other session concentrated on ROJB's scope of work and its processes to supplement knowledge gaps and augment innovations.

Shri. Supongnukshi, IFS presented NFMP's key interventions on forestry and



biodiversity and the project's objectives and expected outputs and outcomes. He also highlighted about the establishment of the ROJB under NFMP, and had invited practitioners and institutions to collaborate in many of the program areas and operational strategies. Further, Shri. Ramashankar, IFS presented Biodiversity and Livelihood Interventions of NFMP. He discussed livelihood improvement and community development through forestry models under the project.

#### 🦇—Institutional Exposure Trip To Odisha

Institutional Training (Certificate Course) on Management of Integrated and Participatory Forestry Project for selected PMU officials, DMU/ADMU Heads NFMP was conducted at XIMB, Bhubaneswar from 17th-23rd April 2022. The training was jointly Organized by IIM, Sambalpur & XIM University, Bhubaneswar. The First batch of training was attended by 19 officials of NFMP and was led by Shri Senthil Kumar IFS, PD (HRD) NFMP. The team undertook field visit to Project village and held interaction with the JFMC members. The team also interacted with GIS/MIS team of OFSDP during the visit to GIS lab.

The Second batch of training was attended by a total of 23 participants from 14th - 19th Nov 2022.

The training aimed to expose the senior officials of NFMP engaged in project implementation on the integrated and participatory forestry project management concepts, approaches and strategies to build and enhance the capacities of the staff around project management tools.





Through this institutional training, it is expected that the participants have a) become aware of different aspects of participatory forest management, b) learn from the experience of Odisha Forestry Sector Development Project Phase I and II, and III) to develop an understanding of the application of learning in the field condition while implementing NFMP. Prof. Neeraj Kumar from XIM University, Bhubaneswar and Dr. Sumita Sindhi, Associate Professor from IIM, Sambalpur coordinated the training program. Experienced resource persons from Indian Forest Services officers, experienced professors from XIM University and IIM, Sambalpur facilitated the technical sessions in the training program. Considering the importance of physical interaction, experience sharing, and exchange of ideas for an in depth understanding and learning, the training was conducted in a physical mode.



The industry experts and faculty members adopted participatory and interactive approach to facilitate the training program. As such, classroom training along with field visit to different OFSDP II project location in Dhenkanal forest division was carried out. Efforts were made to make the training interactive by asking questions, seeking suggestions, and clarifying queries of the participants. Field visit as an approach of learning by seeing and interacting was followed and the participants were exposed to real field situations. During the field visit, the participants were facilitated to discuss with various stakeholders at OFSDP II project and tried to understand the overall implementation structure of the project, its institutional arrangements, key interventions and its sequencing, critical roles played by various entities engaged in the project viz. JFMC, SHG, Animators, Gram Panchayat etc. They also visited various intervention, entry point activities etc.

#### **—**Inauguration of Welcome Gate at Piphema Old Village

Chief Minister of Nagaland Shri Neiphiu Rio,inaugurated Piphema Old Village Traditional gate (EPA), along with 4 other major projects (Children's Park, Farmers' Market, Primary Health Centre and Cultural Hall) on 21<sup>st</sup> October 2022 that was constructed under various projects at Piphema. #### **—** Bird Watching Workshop

DMU Phek in collaboration FES (FNGO) and Bird Count India organised a bird watching workshop at Kami village under FMU Pfutsero on 23rd Nov 2022. Tomal Gogoi, Field Coordinator Bird Count India was the Guest speaker at the workshop. ADMU stressed on the importance of preserving and conserving birds in Nature and its relation to the ecological balance. Tomal Gogoi, shared the importance of bird watching and documenting birds. He explained the dynamics and process of bird watching and methods of identifying the different types of birds based on their eating habits and characteristics. The team undertook bird watching activity for 4 days and were able to document different species of birds under FMU Pfutsero.





# -Community Conserved Areas for Biodiversity Conservation and Voluntary Surrender of guns & hunting weapons to Mishilimi Village Council

Nagaland is located within the Indo-Burma and Himalaya biodiversity hotspots and is rich in forest resources. The Indian Constitution protects customary rights and the majority of natural habitats are owned and managed by local communities, individuals and clans overseen by village councils, district councils and other traditional institutions. Majority of the village communities depend upon utilization of natural resources for their livelihood which has led to over exploitation of forest resources and threats to biodiversity due to the increasing needs of local people. However, through the creation of CCAs in response to forest degradation and loss of wild life, there is a hope for the protection of biodiversity conservation and ecosystem resilience as CCAs are an important mitigation and adaptation strategy for climate change.

Nagaland Forest Management Project (NFMP) was initiated during 2017-2018 and is being implemented in 185 villages in 22 selected Forest Ranges and in 11 Forest Divisions of Nagaland of which Mishilimi Village falls under Pughoboto Range, Zunheboto Forest Division and covers an area over 4500 ha. With the assistance from Japan International Cooperation Agency, the project aimed at forestry interventions and biodiversity conservation, livelihood improvement and community development, Institutional activities and support activities in targeted villages in the state. The model adopted aimed at strengthening the resilience of the local communities and their forests by adopting conservation practices and providing supplementary livelihoods. Activities included compiling information on Indigenous Ecological Knowledge (IEK), motivation and sensitization on landscape conservation and monitoring as well as promoting ecotourism as a livelihood option. Around 76 species of flora and 37 species of fauna have been documented and are being protected in 670 hectares as CCAs where hunting is banned. The Joint Forest Management Committee were satisfied with the documentation of their indigenous knowledge in the micro plan.

To ensure conservation of large contiguous forest areas, an approach for banning of guns in Mishilimi Village was initiated by Mr. Kentsin Kent, Pughoboto Supervisor, FNGO, Youthnet.It was decided to mobilize support to link the community-conserved areas and develop community-based ecotourism initiatives and formalize and mainstream a network of CCAs along with the District Forest Department.Banning of guns came into implementation by engaging with the community, conservation education, and creating awareness of threats and integrated approaches at the community and stakeholder level. This was achieved through participatory planning, knowledge sharing, and capacity building.





The approach of community conservation yielded positive result with the people of Mishilimi Village voluntarily surrendering their guns to the Village Council on 31<sup>st</sup> October, 2022 in the presence of Dr. Prabhat Kumar, IFS, DFO Zunheboto, Smt. Lhinghoikim Touthang, IFS, FMU head Atoizu and FNGOs YouthNet, Zunheboto. Apart from these CCAs, they have also banned hunting across the entire jurisdiction of their village, covering 2347 hectares of forests.

#### — "Green Peren-Green Growers Meet"

As an initiative to promote Income Generation Activities for Self Help Groups (SHGs), Divisional Management Unit (DMU) under the Nagaland Forest Management Project (NFMP) along with Care-Centre for Environment and Rural Poor (C-CERP) organised a two days event on 24<sup>th</sup> and 25<sup>th</sup> November, 2023.

The programme was organised in collaboration with Land Resources Department, Govt. Of Nagaland, Nagaland Tool Room and Training Centre and 25<sup>th</sup> Assam Rifles, Jalukie Townn. Dr. Naieem Mustafa Mansury, Superintendent of Police, Peren and Shri. Vineet Kumar, IAS Deputy Commissioner of Peren inaugurated the event on day one and day two respectively. In his welcome address, the DMU Head cum Divisional Forest Officer of Peren Forest Division, Dr. Prabhat Kumar, IFS DFO cum DMU Head Peren appraised the guests and the public about NFMP activities in Peren District and stressed upon providing good platform on regular basis to the women SHGs and more convergence with other departments in the district.

Speaking on the day one, Dr. Naieem Mustafa Mansury appreciated the efforts of the team NFMP under Peren Forest Division for taking the initiative to organise the programme. He also emphasised on the important role of the women folks in income generation activities. On the second day, Shri Vineet Kumar, IAS Deputy Commissioner of Peren, appreciated SHGs for coming forward to participate in such events. He also stressed upon convergence with other departments in the future to organise such event frequently on a bigger scale. He further assured all possible assistance from the district administration towards such events.

#### Key success of the activity

- Supportive and positive response and active participation from the public.
- Gain rich knowledge in marketing skills.
- Developed confidence to improve their IGA.
- Earned a profit of `61,725/- out of `1,42,695/- expenditure.

#### Outcome

The purpose of the event was to create a common platform for the SHGs to sell and exhibit their local products which include handicrafts, organic vegetables and fruits etc. As many as 23 SHGs from 9 JFMC Villages in Peren District showcased and sold their locally grown and developed products during the two days event in the heart of Jalukie town on the theme "Green Growers-Green Peren Meet".

#### - Convergence with Jal Jeevan Mission at Water Harvesting Structure at Mpai Namci.

The Nagaland Forest Management Project is a JICA assisted Project which aims at Sustainable Forest & Environment Conservation and Livelihood Improvement through community participation. Under the first phase of the project Mpai Namci was selected under the Divisional Management Unit Peren in the year 2019. Mpai Namci is situated at the Southern most part of the district bounded by Manipur state. The village is situated at the hill top with an area of approximate 2682 hectares settled by around 204 household.

Though the village has a low-density/rate of population, water supply to all the household was not connected and need for proper water supply was required. Therefore, through the Nagaland Forest Management Project under the Institutional Strengthening Component the Joint Forest Management Committee under the leadership of Shri. Isipet, Chairman along with the Project officials constructed a Water Harvesting Structure (WHS) which was completed in 2020 but the structure alone wasn't enough to supply water.

Subsequently, with the active participation of the Joint Forest Management Committee (JFMC) and the village council, water pipelines were connected from the main water source till the water storage structure constructed on 2021 contributed by the Mpai Namci village council. Later on, in the year 2022, pipeline connection to the entire household was carried out by the PHED department under the Jal Jeevan Mission and accordingly by end of 2022 around 32 household/points have been completed. The Jal Jeevan Mission also aims to connect water pipeline to all household in the village which are to be taken up on the coming years.

#### Value Added Products of Fish

# An initiative to improve both nutrition and livelihood among SHGs by training through convergence'

Fish is one of the healthiest foods for human beings. It is filled with important nutrients such as protein, Vitamin D and other minerals. Fish is also a great source of omega-3, which plays an important function for the development of one's body and brain. Studies have shown that people who consume fish on a regular basis have lower risk of heart attacks and other heart related diseases.

In Nagaland, there is a huge potential for development of aquaculture as the State is endowed with rich natural resources. Local farmers are now coming forward to take up aquaculture along with other agricultural activities. State Fishery Department is making special efforts to develop fish culture by adopting integrated farming, paddy cum fish culture, reservoir fisheries and other methods. As per Government records, there are about 149 species of fish found in Nagaland.

In the Naga society, fresh fish cooked with fermented bamboo shoot along with local spices is a common speciality. It is also dried for preservation after which various items are prepared including chutney. Of late, food products prepared from fish such as fish pickle, fish finger and fish balls have become a popular addition in the Naga food. The State Department of Fisheries and Aquatic Resources have been actively imparting trainings to the rural population on making such products.

Under the Nagaland Forest Management Project, Self Help Groups of Batch – I & II villages under DMU Kohima received hands-on demonstration and training on how to make fish pickle, fish finger and fish balls. The training was held on 1st September 2022 at the Conference Hall of the Forest Office Complex, Kohima in convergence with Department of Fisheries & Aquatic Resources. During the training, Smt. Sentinaro, District Fisheries Officer, Kohima shared about the various ingredients and demonstrated on how to make the various products.

#### — Swine Flu Vaccination for Pigs under Convergence with Department of Veterinary

The outbreak of African Swine Flu (ASF), in parts of Longleng, Mokokchung, Mon earlier this year and parts of Kohima and Dimapur has triggered panic and fear among people who rear pigs. Many farmers especially in the villages incurred heavy financial losses due to sudden deaths of pigs. As per the local dailies, 6403 pigs were confirmed dead in Nagaland due to ASF this year.



Establishing a pig vaccination program helps to protect the herd from contagious diseases at all stages of development. Vaccination is an important tool for disease control in swine herds. It is important for the farmers to vaccinate their pigs to prevent or decrease economic loss from infectious diseases and improve livestock management. Under the Nagaland Forest Management Project, in Nsunyu village of Tseminyu range in Batch I, the three selected Self Help Groups are Sang Kemehi, Kajan Zie and Kecha Zie.

These three SHGs have selected Piggery for their Income Generation Activity (IGA) and the Sang Kemehi SHG is rearing 6 piglets, Kajan Zie and Kecha Zie 8 piglets respectively. With the increase of swine flu cases in the State, these SHGs, IGA are at higher risk and hence with the support of Veterinary field assistance under the Veterinary Department, vaccination drive was conducted on 29th July 2022.

The Veterinary field assistance from the village has vaccinated 22 piglets of the three SHGs combined. The vaccination given to the piglets is Lapinised, which is a vaccine for swine flu.

#### And Construction of village gate under Entry Point Activity

Throughout the history of the Naga culture, the village gates served numerous purposes. Made of strong and huge woods, the Naga village gates were boldly adorned with decorative carvings depicting the tribe's unique culture, identity, history and unity. The carved motifs are not only striking but also etched with deep meaning. Traditionally, the gates were strategically built at the entrance and exit points of the village to avert the entry of their enemies. A typical Naga gate speaks its own distinctive story.

Today, the few of the age-old traditional gates that remains are being conserved and maintained by the village community, keeping the legacy of their ancestors alive. In the present context, the different Naga tribes construct magnificent village gates to re-establish their identity and also to commemorate any important events in the village and remember their founding members.

Located under Tseminyu district is Terogvunyu, one of the villages under Nagaland Forest Management Project. Under the project, the Joint Forest Management Committee members decided to merge the funds under EPA and WHS to construct the village gate, which has been the long felt need of the village and the foundation of which was laid on  $2^{nd}$  June 2022 during the visit of JICA officials to the village. Though over 100 years old, the village do not have a proper gate and therefore, the village community have expressed gratitude as the much needed asset of the village is being materialized through the Project.

#### 🦇— Health Camp Conducted at Terogvunyu Village

DMU Kohima organized a one-day medical camp on 27<sup>th</sup> November 2022 at Terogvunyu village, Batch - II under Tseminyu. The main purpose of conducting the health camp was to provide basic health services and diagnosing major health issues early, targeted towards the elderly group of people. During the camp, Dr. Anshida K MBBS, MD Ophthalmology (AIIMS Delhi) provided services such as eye check up, Blood Pressure, sugar level test and arthritis along with free medicines and prescriptions.

In the health camp, the participants were mostly the elderly folks from the village who could not travel to for medical check-ups. It was found that most of them were in the age group between 50-80 yrs. Many of them were with hypertension (high BP), arthritis and some of them were suffering from post-traumatic injury. The visiting doctor advised them on diet and exercises that they should do on their part in order to live healthily. A few of the children who were present during the health camp were suffering from minor sicknesses. The youngest participant was a 10 months old baby who had been suffering from teary eyes. For this, the doctor advised the mother to massage the baby's nose for proper blood circulation in the nerves leading towards the eyes.

The health camp was a success as the individuals who needed the service the most availed it. Altogether, 45 beneficiaries availed the services from the health camp.

#### Convergence Activity with the line Department under DMU Mokokchung

Based on the success rate of Towards Livelihood Improvement-1, a Livelihood Project under LADP (Local Area Development Project/Fund) common Pool 2021-22 was also designed with the initiatives of Mokokchung District Planning Development Board (DPDB) in consultation with the DMU Mokokchung team. Under this project 10,000 no's of 14 days old vaccinated cob 430y Broiler chicks were distributed to all the selected farmers/SHGs of 10 Constituency Assemblies under Mokokchung District and the same Management module of the Towards Livelihood Improvement Module-1 was practised and analysis of performance index of every 2 weeks were taken.

The analysis shows that survival rate was equally good for all the constituences. The average body weight gain ranges from 1.5 to 3.4 kg. The Koridang A/C excels in FCR & BFEI and the Mokokchung town constituency excels in BPEF.

Based on the analysis of all the documents given and on sustainable Livelihood basis, the best farmer was awarded to Mr.Moatemsu of Aonglenden A/C.

#### ♣─Two days Training on Food Processing under Batch-I & II

A Two days training in collaboration with Krishi Vegyan Kendra on Food processing and value addition was conducted at DMU Mokokchung Office, Marepkong from August 22<sup>nd</sup> to 23<sup>rd</sup>, 2022. The programme was chaired by Akumtoshi Longkumer (Team Leader FNGO) during the inaugural programme Dr. Sentitula (IFS), DFO cum DMU Head gave a keynote address followed by inaugural speech by Dr Keviletsu Khate, Senior Scientiest & Head KVK, Mokokchung. The Technical session for the training was chaired by Moaienla Longkumer, Technical Officer, KVK, Mokokchung. In the two days training session, the topics were on preparation and sterilization of bamboo shoot pickle, green chilli pickle, squash &



RTS, Jam (Pineapple & Papaya), Ginger Candy & Tapioca. A total of 27 SHGs from 9 villages under Batch-I & II are participating in the training.





### - Construction of artificial pond at PEC area under Angangba village batch-II, in collaboration with RD department

Under FMU Longkhim Range, the only water source for Angangba village, Longkhim town, Sangsomong village, Holongba village and Yangli Mission Center is at Angangba village reserved forest. In this regard under NFMP, the particular forest area has been taken up as PEC Treatment area since the village has taken up required plantation in that area in collaboration with RD department. Soil and moisture retention has been done in the form of construction of artificial pond at the water source. With this intervention, the inflow of water has increased, which is sufficient to supply for drinking water to the needy villages. This site has been declared as "AZADI KAAMRIDMAHOTSAV" site in the presence of department and administration.

#### **A** Convergence Activities with Allied Departments

DMU Kiphire conducted convergence activities with allied departments in the NFMP villages. The main objective is to support the village community through convergence of various activities. It also aims to add to their livelihood income through various skill training & programmes.





DMU Kiphire organized Two weeks training for SHGs on "Post-Harvest Management on Fruits & Vegetables" in collaboration with DUDATECH Skill Centre – Nagaland Tool Room & Training Centre under the Entrepreneurship & Skill Development Programme (ESDP) sponsored by Ministry of MSME Govt of India at Anatongre village (Batch-I) on 3th - 9th February 2023 & Pokhpur village (Batch-II) on 10th February 2023. Two weeks training for SHGs on "Natural Fibre Extraction & Handicrafts" was conducted at Zhimkiur village (Batch-II) on 2nd February 2023. The training was initiated by DMU Head Shri. Chisayi IFS, ADMU Head, FMU Head, DMU Support staffs and FNGO members.

#### A Convergence with Medical Department, Kiphire

On 26<sup>th</sup> November 2022, a Multi-Specialty Health Camp as part of Convergence programme was organised by Medical Department in collaboration with Nagaland Forest Management Project at Anatongre Village (Batch-I). The event included general medical screenings, eye exams, dental, gynaecology, paediatrics, and other services. Several tests were also performed, including diabetic/sugar level, malaria, typhoid, HIV, Covid-19 and so on. All patients were given free medication. Around 200 people were screened and treated as a result of this. In addition, an enrolment drive for CMHIS and Ayushman Bharat was carried out. The nearby villages were also invited. Over 30 members of the medical department were involved in this programme.



# Case Study on Convergence Activities (Merangkong JFMC Batch-II Village under FMU Changtongya Beat)

The Nagaland Forest Management Project (NFMP) was implemented at Merangkong Village since in the year 2020. One of its main objectives is Forestry Intervention and Biodiversity though Community participation. The Project also focused on Livelihood Improvement and Institutional Strengthening of the villagers. Under the Project, a Joint Forest Management Committee (JFMC) was set up subsequently. The newly formed JFMC Merangkong established a Nursery with the allotted fund along with the free labour of the committee members in order to supply to the Forestry Intervention model areas in the village.

The nursery is strategically located near the National highway, having proper exposure to sunlight and an immense scope for expansion. During the month of July 2020, the JFMC Merangkong started the construction of the Nursery and as a result they could raise sufficient number of saplings. Artocurpus heterophylus (Polong)1000, Spondias axillaris (Ayit) 22,000, Duabanga grandiflora (Kokhon) 20,000, Chukrasia tabularis(Ait) 10,000, Ailanthus altissimia (Langpangshitsu) 18,000, Parkia roxburgia (Yongchak) 10,000, Phobe species 10,000 etc., are the main saplings in the nursery. The nursery is maintained by the JFMC members successfully. The saplings in the nursery are then distributed to the villagers so as to plant them on the project model areas. The nursery of JFMC Merangkong has raised >90,000 saplings so far with a surplus of 15,000 saplings. In January 2022, the Highway Construction Company – Keystone Infra Pvt Ltd. requested the FMU Changtongya under DMU Mokokchung Forest Division for saplings to be planted on the roadside. A total of 2000 (two thousand) saplings were given to the said construction company from the Nursery of JFMC Merangkong @20/sapling. Thus, the surplus saplings were planted on the whole stretch of Merangkong-Tamlu-Mon road 0+000 to 20+000 km.







#### —Digital Literacy Course

From 12<sup>th</sup> to 14<sup>th</sup> September 2022, DMU Wokha organized a Digital Literacy course training in convergence with Skill Development Department, Wokha and NIELIT Kohima at Forest Community Hall. NIELLT Kohima assisted the trainee by providing Laptop to give first hand practical knowledge on digital marketing.

#### 🦣 — District Advisory Committee Meeting - Phek



#### **—**Training cum Workshop on APO and JFMC Level Record Keeping for all DMU

PMU, NFMP organised a 2 Days Training cum Workshop on preparation for Annual Plan of Operation at SEFTI, Dimapur on 11th and 12th April 2022. Shri Senthil Kumar IFS Project Director (HRD) chaired the Training and welcomed the participants. Shri Vedpal Singh IFS Project Director (IMP) addressed the attendees via video conferencing and highlighted on the importance of preparation of APO and its utility for the DMUs in implementation of the project.



#### Marketing Shed cum WHS (Piphema Old JFMC)

Piphema Old village is one of the villages which is under NFMP –JICA project of Dimapur Division. It is located 39 km away from Dimapur. Piphema Old village is situated on a hilltop which is approximately 2 kms away from the NH 29. There are about 196 household in the village. Agriculture is the most important activity covering 80%-90% of the village economy.

Similarly, to the other parts of Nagaland, Piphema Old practices Jhum cultivation and Terrace cultivation throughout the year. Mixed farming of agricultural products is commonly practiced in the village, which acts as a great source of livelihood income for the villagers. Since the inception of NFMP, the community expressed keen interest in selling their agricultural product and requirement for a permanent space which would help them in displaying their products for marketing. With the intervention of DMU Dimapur, Marketing shed cum Rain Water Harvesting Structure was constructed alongside NH 29 as part of Water Harvesting Structure (WHS). Marketing shed has provided a great opportunity for the community to sell their local products and also created a positive impact by enhancing their organic product from morning till evening on daily basis (Monday to Saturday). According to the vendors, at least 2-3 vendors sell their products daily. The daily income is varied while the approximate monthly income sums up to `12000/- per vendor, which make a great source of income for the family.

Through this initiative taken by Nagaland Forest Management Project (JICA), the vendors expresses that the marketing shed provides them a good shelter to display their products without any cost and it has become a business hub for the villagers, especially for the women, who are now financially free and are contributing in the family as well as in the society.

### A success story on Water Body at Piphema Old Village

Piphema Old Village is one of the NFMP Village of Piphema Beat under batch II which falls under Dimapur District and its located 39km away from District Headquarter, the village is situated above National Highway 29. It has total population of about 497 with 196 numbers of households. Like any other villages in Nagaland, almost all the villagers of Piphema Old is dependent on agriculture for their livelihood. The villagers' practices Horticulture farming, Jhum and terrace cultivation.

Throughout the year the villagers are dependent on rain water for domestic purpose, terrace cultivation and horticulture. Close to NH29 there is a small perennial water body which benefits the villagers for their usage. With the need to increase the size of the pond to catch and store more water, the DMU Dimapur intervened in renovating it. The pond was constructed measuring with length of 40 feet, breadth of 20-25 feet and about 4 feet in depth. It has resulted in increased storage of water which benefits the villagers throughout the year. This activity was completed in the month of September 2022.

Since, the pond is located near the NFMP nursery site, the water from the pond is used to water the nursery seedlings. More than 10 household are benefited from this water body, and it is also used for domestic purpose such as farming, car wash, construction works and hotels located alongside Nh29. The community decided to take the measure by planting more trees, cleaning the surrounding and make fence with barbed wire in order to protect the water bodies. Thus, this water bodies have become a multipurpose for the community which is being utilized by the people for different purpose.

# **Community Development** -

# A-Construction of WHS at Tamlu Village

Before the introduction of NFMP, JICA Project, at Tamlu village (Batch-3), under Longleng District, many families faced untold hardships due to lack of proper water facilities for drinking and household use. Earlier, villagers made use of the temporary rainwater harvesting structure which was constructed by the village council, but most of the times people fetched water from the water sources at the foot of the hill with much difficulty.

The construction of Water Harvesting Structure (WHS) at Tamlu village which began in the month of February 2023 and concluded in the month of April 2023, can be mentioned as a success story for NFMP, JICA Project, as today it benefits around eighty (80) households of the village with undisturbed supply of water.

### A Construction of WHS at Ametchong Village

Ametchong Village, a new village of Tamlu Village, faced the same problem as Tamlu village as their topography and climatic condition is almost the same. After the introduction of NFMP, JICA Project, batch-3 in their village, the villagers decided to use the WHS fund to construct Water Tank for the village.

Earlier, villagers of Ametchong obtained water from deep well which was constructed by the village council, but after the construction of WHS which began in the month of February 2023 and ended in the month of April 2023, the villagers get clean water for drinking and household use. The water tank provides undisturbed water for around eighty (80) households of Ametchong village.

### **A** EPA and WHS at Yachem Village

The story of EPA and WHS at Yachem Village, Batch-3 of NFMP, JICA Project under DMU Longleng can be considered as a success story as it has very high impact on the villagers.

Before the introduction of NFMP, JICA Project at Yachem Village, villagers used to obtain water from the community well and bore-well which was constructed by Village Council. But there was more iron in the water, so villagers had to make temporary filters before using it.

When the JFMC members were

highlighted about EPA and WHS works to be done through NFMP, JICA Project, they decided to Construct Water Tank and to install Water Filtration Plant in three morungs (Colonies) of the village. The construction work began on 13<sup>th</sup> March and ended on 8<sup>th</sup> April 2023. Today, the villagers have the privilege of consuming clean and undisturbed water supply in the village.











#### Success story of EPA, Meluri

Meluri is the largest village under Meluri sub-division of Phek district. It is home to the Pochury tribe of Nagaland and is one of the oldest villages in the state. It is located in the eastern side of Phek district and the sub-division also shares international boundary with Myanmar. Meluri roughly means "overflowing in abundance".

The Joint Forest Management Committee of Meluri decided to construct a toilet at the village council hall for the Entry Point Activity (EPA) under Nagaland Forest Management Project. The decision was taken because although there was a toilet in the council hall, it was in a dilapidated condition. This was a big problem for women as it greatly discouraged them from participating in important deliberations and other events such as council meetings which meant that women's representation in the decision-making process was quite marginal.

With NFMP encouraging meaningful participation of women, a woman was elected as the vice chairperson of the JFMC. Along with the vice chairperson, there were other women representatives who brought to the forefront the plight of women and their right to basic facilities. This urged the JFMC to construct a proper toilet which catered to the needs of everyone. Moreover, Council Hall is utilized by the entire community for different purposes at different times so constructing a toilet there was beneficial to everyone.



The construction began on 26<sup>th</sup> April 2022 and was completed on 18<sup>th</sup> July 2022. There are four rooms consisting of two urinals, one each for men and women and two toilets in the same way. There is electric connection in all the rooms, cleaning tools and pipelines for water to keep the toilet clean. The community came together for the construction and contributed in the form of labor such as unloading the construction materials, cleaning up the area and even working in the actual construction of the toilet. After the completion, the responsibility for maintaining the toilet has been taken by the Council and thereby ensures that it is cleaned properly from time to time and after any event.



The EPA was inaugurated by the then Divisional Forest Officer cum Divisional Management Unit Head, Shri Thepfuhusie, IFS on 17<sup>th</sup> Aug 2022.

The EPA has been a great help for the community especially for women who, after the construction of the toilet, feel encouraged and included. One example of how the EPA has benefitted the community is the fact that, for the first time, a district level event was held for the first time in Meluri at the Council Hall in the form of Miss Phek, 2022. This historic event was hosted by the Meluri Students Union kor Meluri Küchienyri Kügharü in collaboration with Vogue Entertainment Nagaland. The Student Union credits NFMP and JFMC for being able to achieve this feat as without the construction of the toilet through the EPA, they would not have agreed to and successfully organized Miss Phek, 2022.




#### A Success Story of Unity SHG of Hekheshe village

Unity SHG was formed on February 2020 by NSRLM and subsequently included under NFMP. Altogether there are 10 SHG members. The SHG was engaged in Income Generating Activities like, Poultry, Wine making, Pickle making and Flower business. Their business plan is Ginger and Gooseberry candy. Each SHG members collects Rs.30/- every month.

# — Ginger and Gooseberry candy (Hekheshe Village)

The Village is blessed with fertile soil for which the SHG taking the advantages of the abundant resources had decided to carry out Ginger and Gooseberry Candy as their Income Generating Activities from the Revolving Fund provided by the NFMP. The SHG have been producing Ginger and Gooseberry Candy during previous years as well and it has profited the group.

Apart from the activities included in their business plan, the SHG are also involved in making Yongchak pickle, bamboo shoot pickle, meat pickle etc. The SHG sell their products to the NSRLM in bulk and also distribute the products among themselves to sell. With the intervention of NFMP, the FNGO team has assisted the SHG in producing good quality packaging for their products. With the aim to improve market linkages, DMU Dimapur in collaboration with the YouthNet has launched the SHG products at Made in Nagaland Centre Kohima.



Through all these initiatives the SHG have increased in producing their products which have resulted in generating more income. It is estimated that the group earns around 3000/- to 5000/- monthly.

# 🦇—Kadaknath/Black Chicken (Hekheshe Village)

Unity SHG has also started rearing Black Chicken. Black Chicken is also called Kali Masi. Black Chicken has an intense and distinctive taste as it contains more protein than white chicken. It is also consumed by people with chronic diseases and disorders like anemia. It has lower cholesterol, which can be consumed by those with high blood pressure.



# Pineapple Fest (August 17<sup>th</sup> & 18<sup>th</sup> 2022)

Pineapple Fest was organized by the FMU Head (Medziphema Beat), Florence T. Sangtam with the support of the FNGO team and DMU staffs at the Forest Office Complex, Dimapur. It was held for two days i.e. 17 & 18 August. The main objective of the festival was to encourage and uplift the Income Generating Activities of the SHGs by showcasing their products to the general masses in the midst of celebrating the pineapple season. From Hekheshe village, three SHGs took part, Aiko SHG, Kulashi SHG and Unity SHG and from Medziphema village, Vilie SHG and Kroselie SHG took part.

# 🦚— Value Addition Training

Chimonger village is located in Longkhim circle of Tuensang district in Nagaland, India. It is situated 14km away from sub-district headquarter Longkhim and 47km away from district headquarter Tuensang. Chimonger has a total population of 4,996 peoples, out of which male population is 2,607 while female population is 2,389. Literacy rate of chimonger village is 53.88% out of which 55.35% males and 52.28% females are literate. There are about 790 houses in chimonger village.

Since Tuensang is nearest town to Chimonger for all major economic activities, which is approximately 47km away, it is a hard task for the community of Chimonger village to get their basic needs and necessities owing to the lack of proper road condition and communication system. Hence the villagers rely mainly on the locally available items for their daily needs.

With the need to impart knowledge and also with the keen interest of the community to learn and earn through locally available food items, the Chimonger SHGs were given training on value addition on 4<sup>th</sup> August 2023. Not only were the SHGs trained but individuals from the village interested in learning were also welcomed. A total of 29 members attended the training. The training was given by Mrs. Amenla, mother to two and a self-trained individual who generates her income from the food processing methods she had learnt.

She is a self-sustaining and a passionate woman when it comes to activities related to generating income and providing for her family. The resource person was also assisted by four FNGO (Life Care Society) staffs.

Training on different types of pickle making and processing were given which included: Tomato pickle, King chilly pickle, green chilly pickle, brinjal pickle and yongjak pickle. Additional training on donut and banana chips making were also given.

The purpose of the training was to impart knowledge on generating income through self-made and processed food items; it was also to make the community self-sustainable and self-reliant. The training also emphasized on the health benefits of the locally available food items. It was also to make the community aware of the different food items that can be repurposed and processed hence preventing it from going to waste. This is what one of the participant from the training stated, "the process of this pickle making will not only improve our cuisine and provide income but will also improve our health since it all contains organically available items only".

With the training provided, the SHGs are now on the process of making pickles and other items which can be sold within their village as well as in Longkhim, which is the nearest town to them. The income generated through this will be used for further improving their SHGs as a group and also provide for their family as well as for their individual needs.

To encourage Self Help group and uplift their income an initiative was carried out by the Nagaland Forest Management Project, Phek (NFMP) Agriculture department, Department of Rural development, Nagaland State Rural Livelihoods Mission (NSRLM) Meluri Block in collaboration with administrative department. The initiatives were carried out by Tsalimse Sangtam Extra Assistant Commissioner (EAC) Lephori, C. as several Self-Help Groups (SHGs) have shown enthusiasm to sell their goods and products in the market, Therefore on further deliberations all the department decided to pool money and provide handholding support from all the department to kickstart the market.

# — Livelihood enhancement and Convergence Programme of Nursery Extension with NGOs for JFMC Merangkong Village under Direct Aid Programme supported by Australia Consulate

The present convergence activity is being implemented by FNGO Mokokchung under DMU Mokokchung funded by Australia consulate under Direct Aid Programme that aims at improving food production through green technology intervention at Merangkong village.

Having experienced the hard reality especially during the pandemic crisis, our communities have learnt a hard lesson especially on the food sector where we are still depending on other state for our essential commodities. Some of the reasons for this problem are the traditional practice of farming, lack of technical knowhow, and lack of irrigation facilities. Due to this hurdle, most of the off-season crops and vegetables consumed by the villager are being brought from the outside market despite them having ample lands where they could have grown for themselves.

Considering at all these factors, setting up a proper horticulture/Agri nursery with irrigation facilities within the village itself and providing quality seeds or seedlings to the villagers, the production of all these daily consumable vegetables could be up-scaled. The cultivation of off-season crops could also fetch double price of the normal amount thus increasing the income of the villagers substantially.



With the funds support from Australia Consulate, the FNGO Mokokchung (Nagaland Development Outreach) helped construct a permanent Germplasm depot cum nursery in community land by developing a green house with irrigation facility and bringing in technical inputs through convergence from other departments. In the meantime, the FNGOs will identify farmer's group/youth group/SHG/Agripreneurs through consultation with the village council to impart intensive training on various cultivation practices within the village for holistic growth and development.



#### A-IUCN Members' Visit Terogvunyu Village

Members from IUCN, Indian Environment Law Organization & The Nature Conservancy, visited Terogvunyu village on 25<sup>th</sup> January 2023 and were accompanied by senior officials from Nagaland Forest Department, Haryana Forest Department and three members from Khonoma Nature Conservation and Tragopan Sanctuary. During the visit, various Forestry Intervention Models being taken up in the village and the ongoing EPA's were briefed to the visiting officials. The visiting team also reviewed different types of registers, maintained by the JFMC members. The visiting team gave positive remarks on the conservative initiative of the Community and Forest Department. They also remarked that the SHGs have great potential to enhance their livelihood.

#### — Tata AIG CSR Project in NFMP villages

Under the support of Tata AIG CSR Project Financial Year 2022-2023, Integrated Rural Development -Pathways for Rural Prosperity through Piggery enterprise in 5 villages in Nagaland has been implemented in NFMP project villages. The Project focuses on piggery to increase the income of the community for a period of 4 months, i.e., from Dec 2022 to March 2023. In NFMP Batch-II villages, namely Phenwhenyu, Ehunnu, Terogvunyu, and Tsosinyu, 115 beneficiaries has received the support in the form of 1 cost of piglet.


