Development activities of various department are being converged in the project villages through DMUs and FMUs. The present guarter witnessed such convergence activities through the Department of Animal Husbandry, Health & Family Welfare, Agriculture and other institutions like NABARD and IDAN. Various training programmes and monitoring of the project works were carried out in this quarter.

Training on Banana Fiber Extraction in convergence with Nagaland Tool Room & Training Centre (NTTC):

The Training was conducted on 20th-26th February 2024 simultaneously at Hekheshe Village and Piphema Old Village. The training was conducted in the interest of the SHGs and the availability of wild banana raw material in the village. The Training which started in the month of Feb 2024 across 5 JFMCs (Hekheshe, Piphema Old, Pherima A, Sirhi Angami & Ruzaphema) reached its culmination at Ruzaphema Village. During the training a total of 72 Women and 18 Men participated in the training.



- * On 4th Mar '2024, Shri. Bendangtemsu FMU head along with FMU staffs visited Piphema Old village. As per the JFMC resolution in the previous meeting for construction of a Resting shed inside PEC treatment model, the inspection team along with JFMC members visited the PEC model intervention site to oversee the ongoing construction of the Resting shed. The resting shed was constructed from the contributions made by the JFMC members from their beneficiary wages earned during the project activities.
- * On 8th of March 2024, FMU head Piphema along with FNGO team led by Team leader and DMU Staff visited Piphema Old village (Batch-II) and organized al function for the SHG women members to mark the International Women's Day celebration with the rest of the world. Short speeches from FMU head and FNGO team, gifts presentation from FMU, and refreshment from FNGO were made a part of the celebration programme.
- * On 28th and 30th March 2024 FMU staffs along with JFMC members undertook monitoring & evaluation exercise for the Batch-I village i.e Thekrejuma village (Batch-I). Sample plots for the three treatment models i.e JAF, JFF & JCF were laid as per the prescribed methodology and later took measurement of girth/height for both planted and ANR saplings.

DMU Phek: SHG stall at Republic day 2024:

DMU Phek in collaboration with FNGOs organized a stall for display of SHG products at the 75th republic day celebration at Meluri town. Lona SHG under Meluri village sold IGA products at the stall.

Free Prior Informed Consent for Batch IV villages:

Team comprising ADMU Head, FMU Head Pfutsero and staffs, DMU support staffs and FNGOs conducted the FPIC program with the village council members and different organizations under the village body. The villagers were apprised of the NFMP and its objectives. Following the program they were happy for the implementation of the project in their villages and promised of full cooperation in their capacity to be a part of the project. * JFMC consultation meeting was held on 14th March 2024. The meeting was conducted in collaboration with FES and DMU Phek.

DMU Kipire: Convergence activities with Veterinary Department:

- * Through the initiatives of the DMU, FNGO & FMU Kiphire conducted a convergence programme with veterinary Department at Anatongre, Batch-I NFMP villageon 3rd Feb 2024.
- * Multi vitamins supplements were given to 73 households, Pig de-worming medicines were given to 150 households and the second dose is to be administered after six months.
- * The convergence team was led by ADMU Head Shri. Chupitho, FNGO Team Leader Shri. Janai Zeme along with field staffs & veterinary staffs.

Convergence Health Camp with Medical Department:

Convergence activities as one of the major component under NFMP project, Divisional Management Unit, Kiphire in collaboration with Chief Medical Officer' Office, Kiphire organized a one-day Health Camp at Penkim, Batch-II NFMP village on 1st March 2024.

The team was led by FMU Head Shri. R.Aaron Yimchunger & District Immunization Officer Dr. Yelo T. Mero along with DMU staffs & Medical staffs.

The Health Camp began with a short introductory program. DPM, NHM Shri. Limawati chaired the program after which invocation was pronounced by Shri. M. Ato Pastor, Penkim Baptist Church.

Short speech was delivered by FMU Head Shri. R. Aaron Yimchunger. FMU Head during his short speech briefed a short introduction on the NFMP project under Kiphire district. He also spoke on the importance of forest conservation & also urged the communities to avail health benefit program such as this.

District Immunization Officer Dr. Yelo. T. Mero also delivered a short speech. He deliberated on the importance of health related issues and motivated the village communities to avail health care facilities in the nearest health centers.

Penkim Village Council Chairman Shri. Hantskih also took time to acknowledge both the departments for their initiatives in organizing Health Camp at their village. He stated that this kind of program is very beneficial for the village communities & also requested the departments to bring more of this kind of programs in the near future.

The health camp was conducted for a total of eight villages, 73 OPD were registered & 65 NCD screening with 10 number of dental checkups & 18 numbers of children were treated by the Pediatrician.

The services provided during the health camp were: 1. Malaria screening 2. HIV test 3. NCD, screening 4. Dental checkup & general health checkup.

DMU Kohima:

* The JFMC members of Terogvunyu carried out maintenance activity at the JCC and JCF plantation sites on 2nd January 2024 at Terogvunyu (Batch-II villages).

Inspection of springshed and watershed development at Terogvunyu (Convergence under NFMP and NABARD):

Inspection of springshed and watershed development at Terogvunyu (convergence under NFMP and NABARD) was carried out on 17th Jan. 2024. With the grant support from NABARD, "Springshed Based Watershed Development Programme" is implementing a three-year project in two villages (Terogvunyu and New Terogvunyu) with coverage of 300 Hectares for FY 2023-26. The duration of the project is three years from April 01, 2023, to March 31, 2026.

The main objective of the Project is:

- * To improve soil & water conservation and land use
- * To revive dying springs in the watershed area
- * To improve the income opportunities of the community

Activities done under Springshed and Watershed Development till Dec 2023:

- * Springshed and Watershed Development
- * 1500 numbers of recharge pits measuring (0.6m*0.3m*0.3m) each were constructed at the recharge area of two springs covering an area of 19.3 ha in total.
- * 1311 numbers of Staggered Contour Trenches (SCT) measuring (2m*0.6m*0.45m) each were constructed at the recharge area of two springs covering an area of 3.8 ha in total.
- * 65 numbers of recharge ponds were constructed at the recharge area of two springs covering an area of 0.36 ha in total. The dimension of a recharge pond is (2m*1.2m*1.2m).

Activities done under Springshed and Watershed Development in Jan 2024:

- * 600 numbers of recharge pits measuring (0.6m*0.3m*0.3m) each were constructed.
- * 20 numbers of recharge ponds were constructed at the recharge area.
- * 1 Spring box was built in Terogyunyu village.
- * 1 Rainwater harvesting structure is built in New Terogvunyu village.
- * 1 pound is dug in Terogyunyu village.

Monitoring of Demo plot at Seiyhama:

Under the Convergence programme with District Agricultural Office, Kohima and Divisional Management Unit, Kohima, NFMP, vegetable seeds comprising peas, beans and radish were distributed to the members of the three SHGs of Seiyhama village (Batch II under Chiephobozou Range) on 9th October 2023. A demo plot was created at Seiyhama and the vegetable seeds were planted. Inspection of the demo plot was carried out on 30th January 2024 of the demo plot at Seiyhama. It was found that peas and radish seeds which were sown at the demo plot were thriving except for the beans.

* Keteno Longwa SHG, one of the SHGs from Terogvunyu village under Batch-II villages has sold 11 and half crate of eggs earning them Rs. 3295/ during the month of January 2024. The rate of the eggs per crate is Rs.310/-

Convergence with Investment and Development Authority of Nagaland :

Under convergence with Investment and Development Authority of Nagaland (IDAN), site visitations for cold storage unit were completed in NFMP villages under Tseminyu. On 1st February 2024, Phenwhenyu village (Batch - II) was selected. A meeting was conducted with village council and church leaders and village level organisation for the plan of constructing the cold storage with capacity of 5MT. The construction has started and scheduled to be completed by March 2024.



Convergence with Agri Department:

In the month of October 2023, the Agri department provided 25 kg of garden pea to the Village Level Organization (VLO). The VLO decided to cultivate all the 25 kg of garden pea in a group plot in the village. In the month of February 2024, the VLO harvested 100 kg and earned a total amount of 5,000 rupees by selling it for 50 rupees per kg.

Training for Community Mobilizers:

One day training for community mobilizers on data collection was conducted at Tseminyu village on 4th February 2024 under the Convergence programme on Integrated Livelihood Programme and TATA AIG. Community mobilizer of Zisunyu village (Batch IV under Tseminyu) also attended the training which was conducted by FNGO Supervisors.

Annual Review:

Annual review of projects implemented in Tseminyu was organised on 19th March 2024 at Zisunyu Council hall. Altogether, 10 Community Mobilizers along with 7 team members from FNGO and 1 DMU representative attended the review workshop. The agenda included achievements versus target for Financial Year 2023-2024 and plans for Financial Year 2024-2025. Issues and challenges faced during implementation of project activities were discussed including possible solutions to address in the next Financial Year.

Animal Health Camp:

Animal Health camp was conducted by FNGO Kohima Team in Tsosinyu (Batch - III) and Gwachonlo (Batch- IV) villages where pigs and chickens were treated. Deworming, sanitation drives and sensitization of farmers on care and management of pigs and poultry birds were carried out by veterinarian Dr. Vihielie Sanchu, Project Anchor NEIDA. Veterinary Medicines were also distributed to the village members.

Supply of Oyster Mushrooms, kroiler chicks & feeds:

SHGs members of Terogvunyu (Batch - II) and Gwachonlo village (Batch IV) were given 80 packets of oyster mushrooms spawns, while 987 kroiler chicks and 50 bags (50 Kg capacity) of compound feeds were distributed to Phenwhenyu village through Nzon Nyegi Farmers Producer Organization Cooperative Limited.

Promotion of NTFP:

Under the promotion of Non Timber Forest Products, 1300 bunch of broom was harvested from Tsosinyu (Batch - III) and Gwachonlo (Batch- IV) villages and will be marketed through Nzon Nyegi Farmers Producer Organization Cooperative Limited. It is expected to make a turn over of 39,000 rupees through the sale of broom.

Pickle making:

FNGO Team Kohima organised a one day training on pickle making at Seiyhama (Batch - II) on 6th March 2024. SHGs members were apprised on the various procedure of making radish pickle, which were harvested from the demo plot for income generation activity as a part of post harvest management

Training on Millets Cultivation and Distribution of Millet Seeds:

Nagaland Forest Management Project, Divisional Management Unit, Longleng Division in collaboration with FNGO, LEMSACHENLOK and Agriculture Department, Longleng, Nagaland organized a training on millets cultivation and distribution of millet seeds at Agriculture Office Longleng on 5th March 2024.

During the program, Shri. Chingsang Phom, Agri Officer Longleng who was the main speaker, highlighted about the importance of the millet plantation which was very common practice of many Phom villagers. He briefed them about its health benefits, its medicinal values and various steps required while planting millets and measures to prevent crop damage. Two to three members from 11 SHGs of various villages under DMU Longleng participated and benefitted from the training.



Liroyim: Microplanning

Participatory rural appraisal for Liroyim village was conducted on 1st March 2024. Headed by FMU Head changtongya, DMU support staff and FNGO team, Information such as village resource mapping, social mapping, Focus group discussions and village development plans were collected. Village transect was also carried out along with field survey of nearby proposed forestry model areas.

Preliminary field survey works for identification and selection of forestry model areas at liroyim was conducted on 14th march 2024. This was carried out by the staff of FMU Changtongya along with the villagers. GPS coordinates of certain field areas were collected for further studies and record
