The much awaited Eco-Park was officially inaugurated in Kohima on December 1, 2024. Inauguration was done by Hon'ble Chief Minister of Nagaland, Shri Neiphiu Rio in the presence of Shri Ono Keiichi, Ambassador of Japan to India. The Eco-Park was created with the funding of JICA and is located in a historical area at the City Centre. The Park will serve as a green urban space with recreational facilities and a market place for local produces.

During the quarter, Convergence activities with departments like Veterinary and Animal Husbandry, Agriculture and Skill Development took place.

Mid-Term Evaluation of the Project is being undertaken involving third party. MTE team visited the districts of Mokokchung, Peren, Phek, Tuensang, Wokha and Zunheboto. The team visited and evaluated various activities like nurseries, plantations under different Models, Entry Point Activities (EPA) and Water Harvesting Structures (WHS). The Eco Park in Kohima was officially inaugurated on December 1, 2024, by Nagaland Chief Minister Shri Neiphiu Rio and Shri Ono Keiichi, Ambassador of Japan to India. Located in a prime historical area at the City Center, the park will serve as a green urban space for both locals and tourists, offering recreational opportunities like jogging, family outings and a marketplace, while promoting environmental awareness. The park will also create livelihood opportunities through kiosks, retail outlets and a craft bazaar, contributing to the local economy.

In observance of Wildlife Week 2024, the following District Management Units (DMUs) successfully promoted the theme 'Wildlife Conservation through Coexistence' through collaborative initiatives with various schools and organizations.

- **Kohima:** Kohima Forest Division, in collaboration with Nagaland Forest Management Project (NFMP) and KFW, DMU, organized competitions such as drawing, painting and quiz at Trinity School, Government Middle School (T. Khel, Kohima Village) and Government High School (Forest Colony), engaging 92 students.
- **Longleng:** DMU Longleng in partnership with Good Shepherd School, celebrated the event on October 5, 2024 which featured quiz, fun facts and a nature walk to Nagar Vatika, where students learned about local flora.
- **Mokokchung:** JFMCs of Batch-II villages marked Wildlife Week from October 2-8 through awareness programmes and community activities. Merangkong JFMC educated GHS students on human-wildlife coexistence and distributed saplings, while Salulamang JFMC conducted a mass social work initiative involving youth and SHGs.
- **Kiphire:** DMU Kiphire and FNGO EWS in collaboration with the District Administration and Nitoi Village Council, organized an **Airgun Surrender Programme** at Nitoi Village (Batch-IV) on October 2, attended by Shri Rama Shankar Prasad, IFS, DFO Kiphire, and Shri Longdiba L. Sangtam, NCS, ADC Kiphire.
- **Tuensang:** Tuensang Forest Division held a District-Level Quiz Competition on October 7, emphasizing wildlife conservation awareness.
- **Wokha:** FMU Head Wokha Range, DMU Wokha, FNGOs and local representatives celebrated Wildlife Week at Niroyo, Yanthamo, and Phiro villages (Batch-III), attended by JFMCs, SHGs, Student Unions and Village Councils.



WORKSHOPS

Two-day capacity-building workshop:

A two-day capacity-building workshop on "Building Resilient Communities: Women and Sustainable Ecosystems in Nagaland" was organized by the Nagaland State Commission for Women, with support from the National Commission for Women, on 8-9 October 2024, at the SIRD Auditorium, Kohima. Various SHGs under NFMP participated in the workshop.

13th JICA National Workshop of Forestry Projects in India:

The Project Director (HRD), NFMP Nagaland, and DMU Head Mon represented Nagaland at the 13th JICA National Workshop of Forestry Projects in India, held from November 13-15, 2024 at Shillong, Meghalaya. The workshop, attended by states with JICA-assisted forestry projects, focused on cross-learning and sharing experiences in forestry project implementation. A foreign delegation from Kenya also participated, sharing their nearly four decades of experience.

During the workshop, NFMP Nagaland presented a PowerPoint on "Mitigating Impacts of Jhum Cultivation for Sustainable Forest Management," outlining the project's models and their impacts on sustainable forest management.

CONVERGENCE

Animal Service Camp: DMU Kohima Division in convergence with Tata AIG & ILP-2 (Integrated Livelihood Project), organised Animal Service Camps at NFMP villages on 26-27 October 2024. The camps took place in Gwacholo (Batch-IV), Tseminyu (Batch-III), Phenwhenyu, Terogvunyu (Batch-II) and Ehunnu (Batch-III) villages. The main objective of this initiative aimed to provide timely access to healthcare services, particularly for pig health management and to offer preventive care for African Swine Fever (ASF). It also focused on raising awareness about pig health, feed management and hygiene practices at pigsties. The Community Mobilizers supported the Livestock Service Providers in conducting the camps.

Training on improved agricultural practices cum demonstration on pest control management:

Under the ILP-2 project, convergence training on improved agricultural practices for Rabi crops was held at Tseminyu village (Batch-III, Tseminyu Range) on 23rd October, 2024. Training cum demonstration on Pest Control Management in agriculture was also undertaken to help prevent crop damage, with hands-on demonstrations for beneficiary farmers and SHG members. The training covered practical techniques for cultivating winter crops for income generation. A total of 10 farmers attended the training.

Certificate-based Trainings:

The NFMP FNGO team, in collaboration with DMU staff from Kiphire Division, initiated Skill Development Training programme in partnership with NTTC Dimapur and the Department of Industries, Government of Nagaland. These certificate-based training sessions were conducted across various NFMP villages, with the goal of providing alternative livelihood opportunities to the unemployed individuals within the JFMC villages. The training aimed to empower youth, women and men by equipping them with sustainable income-generation skills. The following training sessions were conducted as part of this initiative:

- **Fruits & Vegetables Dehydration and Processing** at Kisetong village (Batch III) from 29th October - 6th November, 2024, with 16 participants.
- **Bamboo Handicraft Training** at Azetso village (Batch III) from 29th October-4th November, 2024, with 16 participants.
- **Bamboo Handicraft Training** at New Longmatra village from 5th-13th November, 2024, with 15 participants.
- **Bamboo Handicraft Training** at Penkim village from 29th October-5th November, 2024, with 30 participants.
- **Banana Fibre/Natural Fibre Extraction and Handicraft** at Seyochung village (Batch II) from 29th October-6th November, 2024.

Training on soap and detergent making:

The training aimed to enhance the skills and livelihood opportunities of SHGs. A total of 17 participants attended the training.

Kiosk Activity and Training on Livestock Management conducted in different Project villages:

DMU Kohima Division in convergence with Nagamaiki Smallholder Pig Producer Company Limited (NSPPC) and Godrej Agrovet Nagaland organized a Kiosk Activity & Livestock Management Training at Tseminyu, Zisunyu, Tsosinyu, Ehunnu and Terogvunyu villages from 25-26 November, 2024. The main objective of this initiative was to offer villagers convenient access to various pig feed products, medicines and other livestock care essentials, with a focus on promoting the quality and nutritional benefits essential for healthy pig growth and productivity. Dr. Rusalie Nakhro, Veterinary Doctor, provided expert guidance on the importance of quality feeds, effective feeding management and the proper use of medicines. The Community Mobilizers assisted the Livestock Service Providers in conducting the Kiosk Activities & Training on Livestock Management in their respective villages.

- The FMU Longleng inspected and installed signboards at all three forestry model areas in Yachem village on 12/12/2024.



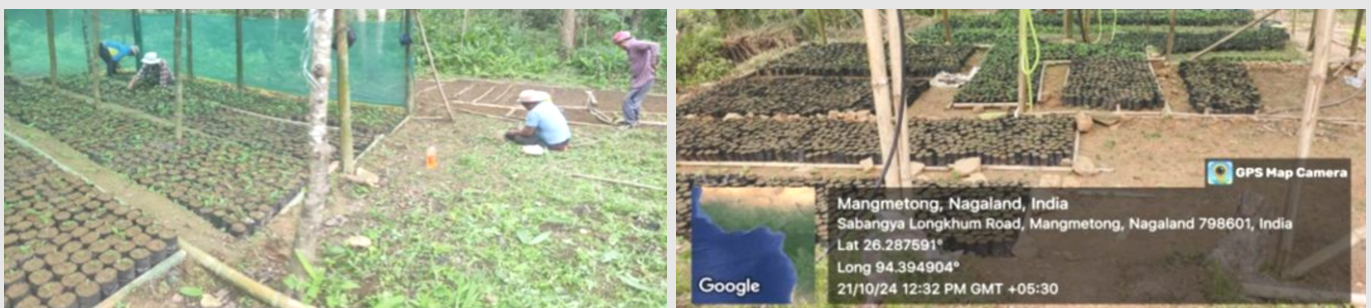

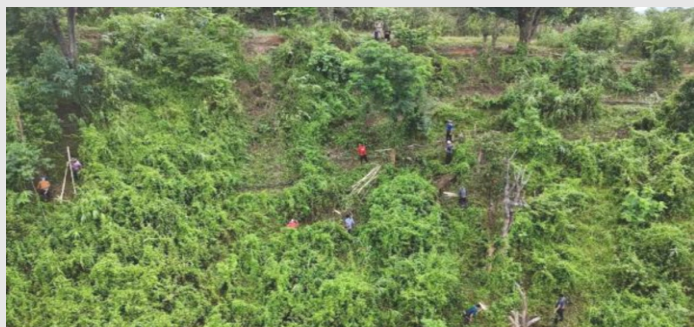
