## *From the Desk*

Soft inauguration of the Kohima Peace Memorial and Eco Park was done on 8<sup>th</sup> May 2024. The Eco Park is being developed as part of the Nagaland Forest Management Project with Official Development Assistance (ODA) from the Japanese government. The inaugural programme was attended by Hon'ble Chief Minister Shri Neiphiu Rio, Shri Suzuki Hiroshi, Ambassador of Japan to India, Shri C.L. John, Hon'ble Minister, Environment, Forest & Climate Change and Village Guards, Chief Secretary to Government of Nagaland, Commissioner & Secretary, Environment, Forests & Climate Change, PCCF & Chief Project Director and other Senior Officers of the State Government. Hon'ble Chief Minister expressed that Eco-Park once completed will turn out to be a critical Centre of urban space and public utility and further said that the park will also become a testament of new found partnership and collaboration between the people of Japan and India, especially the people of Nagaland.

On the project front, during the present quarter various convergence activities like Animal Science Camps and Livestock Management Trainings were conducted in various project villages in collaboration with Department of Animal Husbandry and Veterinary Science.

During the quarter, Shri C.L. John, Hon'ble Minister of Environment, Forests & Climate Change visited the DMU Office Wokha and interacted with DMU Officials on the implementation of the project.

## **Soft inauguration of the Kohima Peace Memorial and EcoPark:**

The soft inauguration programme of the Kohima Peace Memorial and EcoPark was held on 8th May 2024 at Kohima with Ambassador of Japan to India Suzuki Hiroshi, as the special guest.

Speaking at the Inaugural programme Ambassador of Japan to India, Suzuki Hiroshi, expressed his deepest sympathy and condolences to the people of Nagaland who were caught in the crossfire during the war between Japanese forces and the British Commonwealth Forces eighty years ago. He said that the people of Nagaland who had nothing to do with the war inevitably had to go through a great ordeal where many were coerced into cooperation and many people lost their lives and most people were forced to flee from the land of their ancestors. He further added that he was deeply honoured to witness the inauguration of the Kohima Peace Memorial and that the monument enabled us to offer our most solemn prayers to all the victims of the battle.



He expressed his gratitude to the people of Nagaland for their warm welcome and support provided to the Kohima-Japan Bone collection team and for enabling former soldiers and their families to collect the remains of the fallen soldiers. He said that the Eco-Park will be developed as part of the Nagaland Forest Management Project with Official Development Assistance (ODA) from the Japanese Government. In conclusion, he expressed his sincere gratitude to the Chief Minister of Nagaland Neiphiu Rio and also to the people of Nagaland for erecting the peace memorial and hoped that the peace memorial would be a reason for more Japanese people to visit Kohima. "I am convinced that the friendship originally fostered through the remains collection between Japan and Nagaland will be further strengthened through the construction of the Eco-Park as well as the exchange of young people, and they will become new bridges between India and Japan" he said.

Chief Minister, Neiphiu Rio who also spoke at the inaugural programme said that the event marked an important milestone in the narrative of the Naga-Japan partnership which though started under the cloud of conflict had today matured into one for advocating peace and brotherhood of humanity, the message that has been embodied by the Kohima Peace Memorial. He expressed his admiration of Japan for its perseverance and industriousness and how Japan has shown the World what can be achieved through dedication, precision and hard work. Rio highlighted how Nagaland's association with Japan had started almost five decades ago through the Japan



Association for the recovery and Repatriation of War Casualties, an Association that continues till date and the association has now matured into bi-lateral cooperation with Japan under which we have two on going Externally Aided Projects in the forestry and medical sectors. Rio further added that the inauguration of the Kohima Peace Memorial and the ceremony of laying Foundation Stone is the expression of the Naga People's commitment to forge stronger ties between Japan and Nagaland.

Hon'ble CM concluded by saying that the Eco-Park once completed will turn out to be a critical centre of urban space and public utility and the park will also become a testament of our newfound partnership and collaboration between the people of Japan and India, especially the Naga people and will strengthen bonds, enhance bilateral ties and open opportunities for the citizens of the two countries to always pursue common goals.

Minister, Environment, Forest and Climate Change and Village Guards C. L. John thanked all officials and dignitaries who have travelled all the way from Japan and Delhi to attend in the Soft inauguration of the Kohima Peace Memorial and Eco-Park. He emphasised that this Peace Memorial and Eco Park is the realization of a long -felt need in the state given the history of association between Nagaland and Japan. He further highlighted about how 70% of state population is engaged in agriculture mostly traditional method of jhum and shifting cultivation and how this type of traditional method is major reason for loss of forest cover in Nagaland. In such Situation, the Sanctioning of JICA assisted Nagaland Forest Management Project (NFMP) seems providential in rescuing the rich biodiversity of the state. The project objective is to restore forest cover through tree plantation in jhum and promoting conservation of forest through community participation and the project aims to bring an area of 790 square kilometers under forest cover by planting 17 million saplings. He concluded by expressing his gratitude and appreciation to the government and people of Japan for the invaluable assistance towards safeguarding the forest and ecology of Nagaland.

The programme was chaired by Chief Secretary Nagaland J. Alam, IAS who also gave the welcome address while the Vote of Thanks was pronounced by Commissioner & Secretary, Environment, Forest & Climate Change Y. Kikheto Sema, IAS.

### Convergence:

**Animal Service Camps conducted at NFMP villages:** Under Convergence, with Tata AIG & Integrated Livelihood Project-2 project, Animal Service Camps were conducted at Tseminyu, Phenwhenyu, Ehunnu, Terogvunyu villages and at Batch IV villages of Gwachonlo and Zisunyu, Tsosinyu villages (Batch-III). The main objective of this initiative is to provide convenient and timely access to health care services in every village especially for pig health management, providing preventive care services to enable farmers in implementing bio-security measures for African Swine Fever (ASF), raise awareness about general pig health on ASF, importance of feeds management & maintaining Hygiene practices at Pigsties. The Community Mobilizers assisted the Livestock Service Providers in conducting the Animal Service Camps in their respective villages.

**Kiosk Activity & Livestock Management Training:** A convergence programme under Cluster Based Business Organization project in collaboration with Nagamaiki Smallholder Pig Producer Company Limited and Godrej Agrovet Nagaland conducted “Kiosk Activity and Training on Livestock Management” on 25<sup>th</sup> September 2024 at Phenwhenyu Village (Batch-II under Tseminyu Range). The objective of the training was mainly focused on piggery and poultry management practices to the farmers. During the training, importance of selection of breed, feeding management, awareness on variety of medicines, housing, diseases and health care management for better income generation were highlighted.

**Training on Livestock Management:** Training on Livestock Management was organized by DMU Longleng Unit with the support of FNGO in collaboration with Department of Animal Husbandry and Veterinary Service Longleng at Toilanglavlo office, Hukphang village on 6<sup>th</sup> September 2024 for strengthening the SHGs.

During the training representatives from Department of Animal Husbandry and Veterinary Service Longleng explained about the various benefits and risk involved in rearing pigs, broiler chicken, cows, etc., Later, the team distributed vaccines to the SHGs who were rearing piggery.



**Sales Day:** On July 27, 2024, the Nagaland Forest Management Project (NFMP) and the Nagaland State Rural Livelihood Mission (NSRLM) Shom-ai BLF BMMU Mon Block collaborated to organize a Sales Day event at the KNSK Hq Office Complex in Walo Ward, Mon Town. This initiative aimed to boost the income of Self-Help Groups (SHGs) actively involved in the NFMP and NSRLM projects. A total of 8 SHGs from NFMP villages and 5 SHGs from NSRLM were present to showcase a variety of seasonal organic vegetables and local handicrafts, all offered at attractive prices.



**Medical Camp:** The Convergence Program organized by FNGO Mon in collaboration with The Hans Foundation Mobile Medical Unit (MMU) Mon, organized a free medical camp at Totok Chingha village (Batch-III) on 12<sup>th</sup> September 2024. The camp served a total of 99 persons, including women, children, and the elderly. Attendees received free medical check-ups along with free medications. This initiative aimed to provide essential healthcare services to underprivileged individuals and old citizens who may not have easy access to medical care due to its remote location from the District Hospital. The camp was a significant step toward improving community health and well-being, offering much-needed support to vulnerable populations in the village through collaborative efforts and a focus on holistic healthcare solutions.

### Visits/ Inspection:

**Phenwhenyu village:** Shri. Pravanjan Mohapatra, PMC Team Leader along with FMU Head Tseminyu, Shri. The purpose of the visit was to assess the activities implemented as per the Micro Plan and explore possible areas of revision and communities' preferences. During the interaction with the JFMC and SHGs members, the team leader mentioned that that due to the timeline, the community's needs and requirements might have changed from what it was when the first Micro Plan was being prepared. He said, the PMC team will formulate a new template along with guidelines which can be added in the existing Micro Plan of the villages. He also stated that the 2<sup>nd</sup> cycle of the Revolving Fund should be initiated. The team visited the EPA site and the Team Leader was pleased to know that the community bathroom is being used well and maintained well by the community. The team also visited the Agriculture custom Hiring Center (ACHC) established in Phenwhenyu village which was done in convergence with Tata Trust, implemented by FNGO NEIDA.

The facilitators also talked about Microplan and the various exercises involved in the preparation of Microplan. The participants were also briefed on the importance of community participation and women members in achieving the desired goals. Altogether, 75 people took part in the training.

The facilitators spoke on the active participation of JFMCs, which is essential for promoting sustainable forest management while enhancing the livelihoods and well-being of local communities.

The participants were trained on maintenance of various books and records under the NFMP such as Meeting Registers, Stock Register, Assets Register amongst others. They were also trained on how to enter the all the details in the registers with proper signature and dates. In addition, maintenance of cash related documents such as cash book, vouchers, ledgers and muster roll were also trained to the participants. They were also trained on how to enter all the details in the JFMC cash book with proper dates and signatures. In addition, the participants were also sensitized on maintaining proper registers and account related books, which will significantly enhance accountability and boost their capacity.

The SHGs members were also encouraged to practice Pancha Sutra, which includes regular meetings, regular savings, regular inter- lending & repayment and maintenance of proper accounts. In addition, they were also sensitized on the importance of women's participation in overall project implementation and in achieving the project goals.

**SHG Strengthening & Management Module II:** The training on SHG Strengthening & Management Module II was held at the council hall of Ehunnu Village on 19<sup>th</sup> September, with participation of SHGs from Tsosinyu and Tseminyu villages. The SHGs members were trained on SHG profiling format, standard record keeping, model by- laws, Income Generation Activity Formats, preparation of business plan for promotion of IGA, formats for gradation of SHG and format for credit linkage of SHG with bank.
